However, the Board has been informed that, due to the impact of the COVID-19 pandemic outbreak in Vietnam, some of the infrastructure construction work will not be completed by 31 January 2022, and the parties to the Investment Agreement have mutually agreed to amend and extend the date by which certain infrastructure construction should be completed to the satisfaction of the Group to 31 March 2022, or such other date to be mutually agreed upon by the parties (the "**Extension**").

Save for the Extension, all other terms of the Investment Agreement remain unchanged. The Board considers that the Extension is in the interest of the Company and the Shareholders and reasonable in the circumstances as it will provide more time for HTDC to complete the infrastructure construction work taking into consideration the impact of the COVID-19 outbreak in Vietnam.
