# DISCLOSEABLE TRANSACTION FORMATION OF JOINT VENTURE

The Board announces that on 14 November 2013, the Company and Hangzhou Zhuantang entered into the JV Agreement pursuant to which the Company has agreed to procure Hangzhou Kasen, a wholly owned subsidiary of the Company, together with Hangzhou Zhuantang to establish the JV Company to participate in the auction and/or tender of the Land and to cooperate in the development of the Land. Upon establishment of the JV Company, Hangzhou Kasen will be interested in 49% of the equity interest in the JV Company and as it is expected that Hangzhou Kasen will gain control over the board of directors of the JV Company, the financial results of the JV Company is expected to be consolidated into the financial statements of the Group and the JV Company will accordingly be accounted for as a non wholly-owned subsidiary of the Company. The investment of the Company in the JV Company will be funded by internal resources of the Group and bank borrowings.

As the applicable percentage ratios as set out in the Listing Rules in respect of the capital committed to the establishment of the JV Company are more than 5% but is less than 25%, the joint venture arrangement under the JV Agreement and the transaction contemplated thereunder constitute a discloseable transaction for the Company and is subject to the reporting and announcement requirements under Chapter 14 of the Listing Rules.

As the auction and/or tender of the Land by the JV Company may or may not be successful, shareholders and public investors are advised to exercise caution when dealing in the shares of the Company.

#### INTRODUCTION

The Board announces that on 14 November 2013, the Company and Hangzhou Zhuantang entered into the JV Agreement pursuant to which the Company has agreed to procure Hangzhou Kasen, a wholly owned subsidiary of the Company, together with Hangzhou Zhuantang to establish the JV Company to participate in the auction and/or tender of the Land and to cooperate in the development of the Land. If the JV Company is not successful in the auction and/or tender of the Land, the JV Agreement shall be terminated with immediate effect and any payment made by the Company pursuant to the JV Agreement will be refunded in full.

#### THE JV AGREEMENT

Date: 14 November 2013

Parties: (1) the Company; and

(2) Hangzhou Zhuantang.

To the best of the Directors' knowledge, information and belief, having made all reasonable enquiries, as at the date of this announcement, Hangzhou Zhuantang and its ultimate beneficial owner are Independent Third Parties not connected with the Company and its connected persons. As at the date of this announcement, Hangzhou Zhuantang is the sole registered owner of the Land.

# Formation of the JV Company

Pursuant to the terms of the JV Agreement, the Company shall procure Hangzhou Kasen, a wholly owned subsidiary of the Company, together with Hangzhou Zhuantang establish the JV Company in the PRC within three months upon the signing of the JV Agreement. The JV Company will be a company with a registered capital of RMB100,000,000 and will be held as to 49% by Hangzhou Kasen and as to 51% by Hangzhou Zhuantang. The registered capital of RMB100,000,000 will be contributed as to RMB49,000,000 by the Company and RMB51,000,000 by Hangzhou Zhuantang in cash. Such capital contribution was determined after arm's length negotiations between the Company and Hangzhou Zhuantang with reference to the initial capital requirement of the JV Company for the development of the Land. The total capital contribution of RMB100,000,000 will be used to satisfy part of the land premium of the Land, construction costs and other investment costs. Further, upon the entering of the JV Agreement, Hangzhou Zhuantang shall then surrender the Land to the local government in Hangzhou, upon which the local government in Hangzhou shall arrange a public auction and/or tender of the Land and the JV Company will participate in the auction and/or tender of the Land.

Pursuant to the JV Agreement and in consideration of Hangzhou Zhuantang surrendering the Land to the local government for public auction and/or tender, the Company has also agreed to pay earnest money in an amount of RMB19,500,000 to Hangzhou Zhuantang within seven business days upon the signing of the JV Agreement, as guarantee to Hangzhou Zhuantang that the relevant registration procedures regarding the formation of the JV Company will be completed by the Company within three months after the signing of the JV Agreement and that the public tender of the Land will be completed within six months after the signing of the JV Agreement, failing which, the earnest money will be forfeited in its entirety by Hangzhou Zhuantang. In the event that Hangzhou Zhuantang fails to comply with the terms of the JV Agreement or decides not to proceed with the joint venture arrangement as contemplated under the JV Agreement, Hangzhou Zhuantang shall refund the earnest money in full to the Company with an additional RMB19,500,000 payable to the Company as compensatory amount. Further, upon the completion of the development on the Land and upon Hangzhou Zhuantang obtaining the possession of its relevant portion of properties on the Land, the Company and Hangzhou Zhuantang will enter into further negotiations and agreement regarding the arrangement to lease back its portion of properties on the Land to the Company, upon which the earnest money will be used to settle the rental payment payable by the Company under such leasing back arrangement.

Further, to facilitate the establishment process of the JV Company and as a temporary arrangement contemplated under the JV Agreement, the Company has agreed to grant an interest-free loan facility to Hangzhou Zhuantang for the purpose of Hangzhou Zhuantang to satisfy its capital commitment to the JV Company. Upon the completion of the development on the Land, an amount, which will be determined based on the land premium of the Land will be payable by the local government in Hangzhou to Hangzhou Zhuantang as compensation to Hangzhou Zhuantang for surrendering the Land to the local government prior to the development of the Land. Upon the receipt of such payment from the local government in Hangzhou, Hangzhou Zhuantang shall then inject such amount into the JV Company as part of its capital contribution in the JV Company and repay the interest-free loan facility granted by the Company to Hangzhou Zhuantang prior to the establishment of the JV Company. In the event that such payment from the local government in Hangzhou is not sufficient to cover the repayment of the interest-free loan facility granted by the Company to Hangzhou Zhuantang, taking into account the expected auction price of the Land, which is expected to be lower than the market value of the Land, it has been agreed that Hangzhou Zhuantang shall have no further obligation to repay the loan to the Company and the Company waives all its rights to claim such debt liabilities from Hangzhou Zhuantang under such circumstances. Based on the current market price of the Land, the Company considers that the chance of such payment from the local government in Hangzhou being insufficient to cover the repayment of the interest-free loan facility is minimal.

Upon establishment of the JV Company, Hangzhou Kasen will be interested in 49% of the equity interest in the JV Company and as it is expected that Hangzhou Kasen will gain control over the board of directors of the JV Company, the financial results of the JV Company is expected to be consolidated into the financial statements of the Group and the JV Company will accordingly be accounted for as a non wholly-owned subsidiary of the Company. The investment of the Company in the JV Company will be funded by internal resources of the Group and bank borrowings.

## **Business scope and operation of the JV Company**

The scope of business of the JV Company will include property development, sale and lease of properties in the PRC. Upon establishment of the JV Company, the Company and Hangzhou Zhuantang will cooperate in the development and construction of the property project on the Land. The Company shall be responsible for the day-to-day operation of the JV Company, and subject to consultation of the board of directors of Hangzhou Zhuantang, it shall procure the management and implementation of the development of the Land. Further, the Company shall also, at its own costs, be responsible for the design work for the development of the Land subject to such design plan being agreed by Hangzhou Zhuantang.

Further, in light of the local expertise that Hangzhou Zhuantang would be able to bring into the JV Company, the parties have agreed under the JV Agreement that upon the establishment of the JV Company, Hangzhou Zhuantang shall provide certain consultancy services in respect of the development of the Land to the JV Company including coordination works on facilitating the negotiations and cooperations with the local government. In consideration of Hangzhou Zhuantang agreeing to provide such services, the JV Company shall pay an annual consultation fee in the amount of RMB800,000 and RMB1,000,000 in the second year and third year, respectively, to Hangzhou Zhuantang upon the signing of the JV Agreement. The JV Company and Hangzhou Zhuantang will enter into a consultancy agreement regarding such consultancy arrangement in due course. Such consultancy arrangement will constitute a continuing connected transaction for the Company upon the signing of the consultancy agreement. Since the applicable percentage ratios

as set out in the Listing Rules in respect of the consultancy agreement are expected to be less than 0.1%, the consultancy agreement and the transaction contemplated thereunder is expected to be a *de minimis* transaction for the Company under Chapter 14A of the Listing Rules and as such, the consultancy agreement is expected to be exempted from the reporting, announcement and independent shareholders' approval requirements.

## Board composition of the JV Company

The board composition of the JV Company will be determined by the Company and Hangzhou Zhuantang upon when the JV Company is set up. It is expected the majority of the board will be controlled by Hangzhou Kasen. Further, the Company will have the right to nominate the general manager of the JV Company whom will also be the legal representative of the JV Company. Prior to the completion of the development on the Land and unless with the written consent of Hangzhou Zhuantang, the Company shall not (i) change the shareholder as well as the shareholding of the JV Company and/or (ii) enter into any financing arrangement for the project development on the Land (save for the portion being held by the Company), failing which, such act will constitute an event of default under the JV Agreement by the Company and Hangzhou Zhuantang shall have the right to terminate the JV Agreement. Upon termination of the JV Agreement, the Land (including any portion of the Land under construction) shall belong to Hangzhou Zhuantang and the earnest money in an amount of RMB19,500,000 paid by the Company to Hangzhou Zhuantang upon the signing of the JV Agreement shall be forfeited in its entirety.

## Profit/Liabilities of the JV Company

Upon establishment of the JV Company, the JV Company will be held as to 49% by Hangzhou Kasen, a wholly owned subsidiary of the Company, and as to 51% by Hangzhou Zhuantang. The Company will enjoy all the profit and bear all the liabilities of the JV Company.

## INFORMATION ABOUT THE LAND

The Land is situated on the south of Huan Shan Street, Zhuan Tang Sub-district in the Westlake district, Hangzhou with a total site area of 48.75 mu, representing approximately 32,450 square meters. The approved purpose of the Land is for commercial use. The term of the land use rights of the Land granted is 40 years. The total investment amount for the development of the Land is estimated to be approximately RMB200,000,000 (equivalent to approximately HK\$252,652,855). It was agreed between the parties that the development cost of the portion of the Land owned by Hangzhou Zhuantang (being 51% of the Land) shall not fall below RMB3,500 per square meter. In the event that the development cost of the portion of the Land owned by Hangzhou Zhuantang (being 51% of the Land) falls below RMB3,500 per square meter, the Company shall pay an amount equivalent to the difference of the agreed minimum development cost and the actual incurred development cost to Hangzhou Zhuantang. Upon completion of the development of the Land by the JV Company, the relevant properties erected on the Land shall be divided into two different portions, with each portion being distributed to each of the Company and Hangzhou Zhuantang in the proportion pro rata to their respective shareholding in the JV Company, the total site area and location of each of the portions to be distributed to the Company and Hangzhou Zhuantang shall be agreed among the Company and Hangzhou Zhuantang at the early stage of the development. Upon Hangzhou Zhuantang obtaining the possession of its relevant portion of properties on the Land, the Company and Hangzhou Zhuantang will enter into further negotiations and agreement regarding the arrangement to lease back its portion of properties on the Land to the Company at a rental to be agreed by the parties.

The Land, which will be developed by the JV Company, is intended to be developed into a commercial complex with a total gross floor area of 66,324 square meters. The Board considers that the total investment costs for the Land is fair and reasonable having taking into account of the current market conditions, the location, development costs and development potential of Land. The total investment cost for the development of the Land is to be paid in stages and in such amounts as stipulated in the relevant land grant contract. The investment costs for the Land will be funded by the Company by way of internal resources of the Group and bank borrowings.

# REASONS FOR AND BENEFITS OF ENTERING INTO THE JV AGREEMENT

Given that the Land is situated at one of the strategic locations which is in line with the Group's development plan going forward, the development and participation in the development of the Land will enhance the Group's market position and enlarge the Group's market share in such area which is in line with the Group's long term business objective. Accordingly, the Directors (including the independent non-executive Directors) consider that the investment in the JV Company by the Company and the transactions contemplated under the JV Agreement have been made on normal commercial terms and that such terms are fair and reasonable so far as the Company and the Shareholders are concerned and that the JV Agreement and the investment in the JV Company are in the interest of the Company and the Shareholders as a whole.

#### LISTING RULES IMPLICATION

As the applicable percentage ratios as set out in the Listing Rules in respect of the capital committed to the establishment of the JV Company are more than 5% but is less than 25%, the joint venture arrangement under the JV Agreement and the transaction contemplated thereunder constitute a discloseable transaction for the Company and is subject to the reporting and announcement requirements under Chapter 14 of the Listing Rules.

The Company is an investment holding company and its subsidiaries are principally engaged in the production of upholstered furniture, furniture leather and automotive leather. It is also engaged in property development and retail business.

Hangzhou Zhuantang is a rural collective economic organization (農村集體經濟組織) established by Hengqiao Village (横 橋 村) and is principally engaged in the economic development of Hengqiao Village.
