INTRODUCTION

The purpose of this circular is to give you information regarding (i) the proposed grant of general mandates to repurchase Shares and to allot, issue and deal with new Shares; and (ii) the proposed re-election of Directors who are due to retire and to seek your approval of the resolutions in relation thereto to be proposed at the Annual General Meeting.

PROPOSED GENERAL MANDATES TO REPURCHASE SHARES AND ISSUE SHARES

At the Annual General Meeting, an ordinary resolution will be proposed to grant the Directors a general mandate to exercise all powers of the Company to repurchase issued and fully paid Shares up to a maximum of 10% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing of the resolution (the "**Repurchase Mandate**"). PROPOSED RE-ELECTION OF DIRECTORS

As at the Latest Practicable Date, the executive Directors are Mr. Chen Ming Hsiung, Mickey, Mdm. Huang Hsiu Duan, Helen, Mr. Kimmel, Phillip Brian and Mr. Wong Hei Chiu; the non-executive Directors are Mr. Chow Wing Kin, Anthony and Mr. Chan Ho Man, Daniel; and the independent non-executive Directors are Mr. Tam King Ching, Kenny, Mr. Yung Tse Kwong, Steven and Ms. Chan Mei Bo, Mabel.

Pursuant to Bye-law 87 of the Bye-laws, at each annual general meeting, one-third of the Directors for the time being (or, if their number is not a multiple of three (3), the number nearest to but not greater than one-third) shall retire from office by rotation provided that every Director shall be subject to the retirement by rotation at least once every three years. A retiring Director shall be eligible for re-election.

Accordingly, Mdm. Huang Hsiu Duan, Helen, Mr. Yung Tse Kwong, Steven and Ms. Chan Mei Bo, Mabel shall retire by rotation and, being eligible, will offer themselves for re-election at the Annual General Meeting.

Mdm. Huang Hsiu Duan, Helen

Mdm. Huang Hsiu Duan, Helen, aged 57, is the co-founder of the Group. She is responsible for the overall administration and human resources management of the Group. Mdm. Huang has more than 37 years' experience in the footwear industry. Mdm. Huang is the wife of Mr. Chen Ming-hsiung, Mickey, who is the chairman, chief executive officer and executive Director, the mother of Ms. Chen Hung-chun, Fiona and the sister of Mr. Huang Chun-hua, Charles. Ms. Chen Hung-chun, Fiona and Mr. Huang Chun-hua, Charles are senior management of the Group.

Mdm. Huang was appointed as an executive Director with effect from 10 May 1994. Pursuant to the service agreement between the Company and Mdm. Huang, Mdm. Huang's appointment should continue until terminated by the Company or Mdm. Huang by giving to the other not less than three months' notice in writing and without payment of compensation other than statutory compensation. Mdm. Huang is subject to retirement by rotation and re-election at the Annual General Meeting pursuant to the Bye-laws. For the year ending 31 March 2015, it is proposed that Mdm. Huang will receive emoluments of approximately US\$150,000 and HK\$300,000 per annum for being an executive Director, and her emoluments, which are subject to adjustment as appropriate in the future, are determined by the Company with reference to her duties and responsibilities with the Company.

As at the Latest Practicable Date, Mdm. Huang was interested in or deemed to be interested in an aggregate of 299,377,541 Shares, which included her interests in 354,000 share options granted by the Company, representing approximately 43.29% of the total issued share capital of the Company.

Mr. Yung Tse Kwong, Steven

Mr. Yung Tse Kwong, Steven, aged 64, serves as the Chairman of the Remuneration Committee, and a member of each of the Audit Committee and the Nomination Committee of the Company. Mr. Yung was the former Chief Executive Officer of Imagi International Holdings Limited and was the former Chairman of Clear Media Limited, both of which are listed on the Main Board of the Stock Exchange. As Managing Partner of Glocal LLC, Mr. Yung has over 33 years' management experience from leading multinational companies in the media, entertainment, consumer and retail industries. Mr. Yung began his career as a producer with Hong Kong Commercial Broadcasting Company Limited and has since held various senior management positions at The Coca-Cola Company in the United States of America and Asia, served as Regional Managing Director of AC Nielsen China, Hong Kong, Taiwan and Korea and as President of Nielsen Media International. He had been a director of the Cable and Satellite Broadcasting Association of Asia (CASBAA), and is currently a Director of the Child Development Matching Fund and the Tao Fong Shan Foundation Limited. Mr. Yung was also an independent non-executive director of NVC Lighting Holding Limited, a company listed on the Main Board of the Stock Exchange, during the period from November 2012 to June 2013.

Mr. Yung was appointed as an independent non-executive Director of the Company with effect from 1 July 2006. Pursuant to the appointment letter between the Company and Mr. Yung, his term of office is subject to retirement by rotation at annual general meetings of the Company in accordance with the Bye-laws of the Company. For the year ending 31 March 2015, it is proposed that Mr. Yung will receive Director's fee of HK\$180,000 per annum for being an independent non-executive Director and his emoluments, which are subject to adjustment as appropriate in the future, are determined by the Company with reference to his duties and responsibilities with the Company.

As at the Latest Practicable Date, Mr. Yung was interest in 1,600,000 Shares, which included his interest in 570,000 share options granted by the Company, representing approximately 0.23% of the total issued share capital of the Company.

Ms. Chan Mei Bo, Mabel

Ms. Chan Mei Bo, Mabel, aged 42, serves as a member of each of the Audit Committee, Nomination Committee and Remuneration Committee of the Company. Ms. Chan is the founder of Mabel Chan & Co, Certified Public Accountants (Practicing). Ms. Chan has over 21 years' experience in professional accounting field in Hong Kong. She holds a master degree of business administration from the Hong Kong University of Science and Technology in 2000 and a degree of Bachelor of Arts (Hons) in accountancy from City Polytechnic of Hong Kong (now known as City University of Hong Kong) in 1993. Ms. Chan is a Certified Public Accountant (Practicing) in Hong Kong, a fellow member of The Association of Chartered Certified Accountants, a council member and an associate member of The Hong Kong Institute of Certified Public Accountants, and an associate member of The Institute of Chartered Accountants in England and Wales. Ms. Chan is a certified tax adviser and a member of The Taxation Institute of Hong Kong in 2010. She is the past president of The Society of Chinese

Accountants and Auditors, past president and council member of the Association of Women Accountants (Hong Kong) and a member of The Hong Kong Institute of Directors. Ms. Chan is also a member of the Financial Reporting Review Panel of The Financial Reporting Council, a member of the Barristers Disciplinary Tribunal Panel, a member of the Public Affairs Forum of Hong Kong Secretariat Home Affairs Bureau, a member of the CreateSmart Initiative Vetting Committee appointed by the Secretary for Commerce and Economic Development of Hong Kong and a member of the Council of the Hong Kong Baptist University.

Ms. Chan currently serves as an independent non-executive director of another listed company on the Main Board of the Stock Exchange, namely China Weaving Materials Holdings Limited and another listed company on the Growth Enterprise Market of the Stock Exchange, namely South China Land Limited. Ms. Chan was an independent non-executive director of a listed company on the Growth Enterprise Market of the Stock Exchange, namely Code Agriculture (Holdings) Limited, during the period from October 2009 to April 2012 and a listed company on the Main Board of the Stock Exchange, namely Hong Kong Education (Int'l) Investments Limited, during the period from June 2011 to September 2012.

Ms. Chan was appointed as an independent non-executive Director of the Company with effect from 29 August 2011. Ms. Chan has entered into an appointment letter with the Company for a term of three years commencing from 29 August 2011 subject to re-election at the Annual General Meeting of the Company and retirement by rotation at annual general meetings of the Company in accordance with the Bye-laws of the Company. For the year ending 31 March 2015, it is proposed that Ms. Chan will receive Director's fee of HK\$180,000 per annum for being an independent non-executive Director and her emoluments, which are subject to adjustment as appropriate in the future, are determined by the Company with reference to her duties and responsibilities with the Company.

As at the Latest Practicable Date, Ms. Chan had interest in 750,000 Shares, all being share options granted by the Company, representing approximately 0.11% of the total issued share capital of the Company.

Save as disclosed hereof, as at the Latest Practicable Date, and to the best knowledge and belief of the Board, the Directors confirmed that:

- (a) each of Mdm. Huang Hsiu Duan, Helen, Mr. Yung Tse Kwong, Steven and Ms. Chan Mei Bo, Mabel was not connected with any Director, senior management, substantial Shareholder or controlling Shareholder of the Company;
- (b) each of Mdm. Huang Hsiu Duan, Helen, Mr. Yung Tse Kwong, Steven and Ms. Chan Mei Bo, Mabel had no other interests in the Shares which are required to be disclosed under Part XV of the SFO;
- (c) each of Mdm. Huang Hsiu Duan, Helen, Mr. Yung Tse Kwong, Steven and Ms. Chan Mei Bo, Mabel did not hold any directorships in listed public companies in the last three years;

- (d) there is no other information that needs to be disclosed pursuant to any of the requirements as set out in Rule 13.51(2)(h) to (v) of the Listing Rules; and

Pursuant to Rule 13.39 of the Listing Rules, all votes of the Shareholders at general meetings must be taken by poll. Therefore, the resolutions to be put to vote at the Annual General Meeting will be taken by way of poll pursuant to the Bye-laws.

To the best of the Directors' knowledge, information and belief, having made all reasonable enquiries, no Shareholder is required to abstain from voting on the resolutions to be proposed at the Annual General Meeting.

RESPONSIBILITY STATEMENT

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Group. The Directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this circular misleading.

This Appendix serves as an explanatory statement given to all the Shareholders, as required by the Listing Rules, to provide all the requisite information in relation to the Repurchase Mandate.

1. LISTING RULES FOR REPURCHASES OF SHARES

The Listing Rules permit companies whose primary listing is on the Stock Exchange to repurchase their fully-paid shares subject to certain restrictions, the more important of which are summarised below:

(a) Share capital

Under the Repurchase Mandate, the number of Shares that the Company may repurchase shall not exceed 10% of the aggregate nominal amount of the issued share capital of the Company as at the date of the passing of the relevant resolutions granting the Repurchase Mandate. The Company's authority is restricted to purchase in accordance with the Listing Rules. As at the Latest Practicable Date, there were in issue an aggregate of 691,541,445 Shares. Exercise in full of the Repurchase Mandate, on the basis that no further Shares would be issued or repurchased prior to the date of the Annual General Meeting, would accordingly result in up to 69,154,144 Shares being repurchased by the Company. The Shares repurchased by the Company shall, subject to applicable law, be automatically cancelled upon such repurchase.

(b) Funding of repurchase

Repurchase of the Shares will be funded out of funds legally available for such purpose in accordance with the Bye-laws and the memorandum of association of the Company and the applicable laws of Bermuda.

(c) Reasons for repurchase

The Directors believe that it is in the interests of the Company and the Shareholders to have a general authority from the Shareholders to enable the Directors to repurchase shares of the Company on the market. The Repurchase Mandate may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share and will only be made when the Directors believe that such repurchases of Shares will benefit the Company and the Shareholders.

As compared with the position of the Company in its financial statements for the year ended 31 March 2014, being the date of its latest audited consolidated accounts, the Directors consider that there would not be any material adverse impact on the working capital and on the gearing position of the Company in the event that the proposed repurchases were to be made in full during the proposed repurchase period. The Directors do not, however, intend to make any repurchase in circumstances that would have a material adverse impact on the working capital or gearing position of the Company.

(d) Directors, their associates and connected persons

None of the Directors nor, to the best of the knowledge of the Directors having made all reasonable enquiries, any of their associates has any present intention, in the event that the proposed Repurchase Mandate is approved by the Shareholders, to sell Shares to the Company.

As at the Latest Practicable Date, no connected person of the Company has notified the Company that he/she has a present intention to sell Shares to the Company nor has he/she undertaken not to sell any of the Shares held by him/her to the Company in the event that the Repurchase Mandate is granted.

(f) Effect of the Takeovers Code

If as a result of a repurchase of Shares, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purpose of Rule 26 of the Takeovers Code. As a result, a Shareholder, or a group of Shareholders acting in concert (within the meaning under the Takeovers Code), depending on the level of increase in the Shareholder's interests, could obtain or consolidate control of the Company and become(s) obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

Such increases will give rise to an obligation to make a mandatory offer under Rule 26 of the Takeovers Code and will not reduce the amount of Shares held by the public to be less than 25%. The Directors have no current intention to exercise the Repurchase Mandate to such extent as would give rise to an obligation to make a mandatory offer under Rules 26 of the Takeovers Code.

During the six months preceding the Latest Practicable Date, the Company repurchased 8,048,000 Shares on the Stock Exchange at an aggregate consideration of HK\$13,364,840 before expenses.
