#### 1. INTRODUCTION

The Company's existing general mandates to issue shares and to repurchase shares were approved by the Company in the annual general meeting held on 12 June 2017. Unless otherwise renewed, the existing general mandates to issue shares and to repurchase shares will lapse at the conclusion of the 2018 Annual General Meeting.

In order to ensure flexibility when it is desirable to allot additional shares or to repurchase shares, the Directors will seek the approval of Shareholders to grant new general mandates to issue shares and to repurchase shares at the 2018 Annual General Meeting.

The purpose of this circular is to, inter alia, provide you with information on the proposed renewal of the general mandates to issue shares and to repurchase shares and on the retiring directors to be re-elected at the 2018 Annual General Meeting, so as to seek your approval of the related ordinary resolutions at the aforesaid meeting.

#### 2. THE ISSUE MANDATE

Two ordinary resolutions, as set out in the notice of the 2018 Annual General Meeting, will be proposed for the following purposes:-

Ordinary resolution no. 5 – to grant to the Directors a general mandate to issue new shares up to a maximum of 20% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing of the resolution; and

Ordinary resolution no. 7 – to increase the aggregate nominal amount of share capital of the Company which the Directors may issue under the general mandate if given in the Ordinary Resolution no. 5 by the aggregate nominal amount of share capital of the Company repurchased under the general mandate if given in the ordinary resolution no. 6.

The Company has in issue an aggregate of 230,076,062 Shares of HK\$0.10 each as at the Latest Practicable Date. Subject to the passing of the aforesaid ordinary resolution no. 5 and in accordance with the terms therein, the Company would be allowed to issue additional shares up to the aggregate nominal amount of a maximum of 46,015,212 shares on the basis that no further shares will be issued or repurchased prior to the 2018 Annual General Meeting.

#### 3. THE REPURCHASE MANDATE

The ordinary resolution no. 6 as set out in the notice of the 2018 Annual General Meeting, will be proposed to grant to the Directors a general mandate to exercise the powers of the Company to repurchase the Company's fully paid up Shares representing up to a maximum of 10% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing of the resolution.

The Listing Rules contain provisions to regulate the repurchase by companies with primary listings on the Stock Exchange of their own securities on the Stock Exchange.

In accordance with the Listing Rules, the appendix to this circular serves as the explanatory statement, to provide you with the requisite information reasonably necessary to enable you to make an informed decision on whether to vote for or against the ordinary resolutions for granting of the Repurchase Mandate.

### 4. INFORMATION OF THE RETIRING DIRECTORS TO BE RE-ELECTED AT THE 2018 ANNUAL GENERAL MEETING

Mr. Lee, Sou Leung, Joseph ("Mr. Lee"), aged 74, was appointed as an executive director of the Company since 10 July 2003. He is the founder and the chief executive officer of the Group and the chairman of the Board, who is responsible for the strategic planning, business development and overall management of the Group. Mr. Lee has more than 50 years of experience in the distribution of machines tools, advanced equipment and industrial products. Mr. Lee graduated from Wan Yah College, Hong Kong and Hong Kong Technical College (Certificate in Production Engineering), which was subsequently renamed as the Hong Kong Polytechnic University. Save as disclosed above, Mr. Lee did not hold any other directorships in the last three years in public companies the securities of which are listed on any securities market in Hong Kong or overseas. He is the director of certain subsidiaries of the Group.

Mr. Lee has entered into a service agreement with the Company for a term of three years commencing from 10 July 2003 and his appointment would continue thereafter unless and until terminated by either party in accordance with his service agreement. As a director, Mr. Lee is subject to retirement by rotation and re-election at annual general meetings in accordance with the Bye-laws of the Company. Mr. Lee's remuneration consists of basic salary of HK\$1,560,000 per annum and a discretionary bonus and is commensurate with his duties and responsibilities as an executive director in the prevailing market situation.

Mr. Lee is a substantial shareholder of the Company. As at the Latest Practicable Date, Mr. Lee is interested in 167,801,982 shares of the Company within the meaning of Part XV of the SFO. Save as disclosed, he does not have other relationships with any directors, senior management or other substantial or controlling shareholder of the Company for the purpose of the Listing Rules and does not have any interests in shares of the Company within the meaning of Part XV of the SFO.

Mr. Wong Man Shun, Michael ("Mr. Wong"), aged 53, has been appointed as an executive director of the Company since 1 January 2013. Mr. Wong is currently responsible for new business development of the Group.

Mr. Wong holds a Bachelor of Science Degree in Engineering from the University of Hong Kong. He joined the Group in 1986 and had been responsible for the trading business of various products in the Group. He was promoted to the director of Leeport Precision Machine Tool Company Limited on 1 January 2004. Mr. Wong is also an Honorary Vice President of the Hong Kong Electrical Appliance Industries Association, an executive committee member of the Hong Kong Mold & Die Council and a Director of the Hong Kong Mold & Product Technology Association.

Save as disclosed above, Mr. Wong does not hold any other position with the Company and its subsidiaries. As at the Latest Practicable Date, he has held no other directorships in the last three years in public companies, the securities of which are listed on any securities markets in Hong Kong or overseas, nor has he held any other major appointments and qualifications. Pursuant to Mr. Wong's service agreement with the Company, his appointment is for a term of 3 years commencing from 1 January 2013 and would continue thereafter unless and until terminated by either party giving three months' written notice in accordance with his service agreement. As a director, Mr. Wong is subject to retirement by rotation and re-election at annual general meetings in accordance with the Bye-laws of the Company. Mr. Wong's remuneration consists of a basic salary of HK\$1,365,000 per annum. In addition, for each completed year of service, Mr. Wong is entitled to a bonus equal to one month's average salary and a discretionary bonus. Mr. Wong's remuneration, which is commensurate with his duties and responsibilities held, is approved by the Board with reference to the prevailing market situation for a similar appointment. He is entitled to HK\$1,433,250 for his remuneration (including retirement fund) in the financial year 2017.

As at the Latest Practicable Date, Mr. Wong is interested in 1,432,000 shares of the Company within the meaning of Part XV of the SFO. Mr. Wong does not have relationships with any directors, senior management, substantial or controlling shareholders of the Company for the purpose of the Listing Rules.

Mr. Pike Mark Terence ("Mr. Pike"), aged 61, has been appointed as independent non-executive director ("INED") since May 2003. His appointment is for a term of 1 year and may be extended thereafter for such period as the Company and Mr. Pike may agree in writing.

Mr. Pike is a member of the Australian Institute of Company Directors (AICD), an associate of The Institute of Chartered Accountants in Australia (ACA) and member of The Hong Kong Institute of Certified Public Accountants (CPA). He holds a Bachelor of Economics, University of Sydney and Masters of Science in Environmental and Natural Resource Economics, National Agricultural University, Lima, Peru. Mr. Pike worked in Hong Kong for many years in the commercial and not for profit sectors. He is currently a director and corporate advisor in Brisbane, Australia.

Except for being a director of the Company, Mr. Pike did not hold any other directorships in the last three years in public companies the securities of which are listed on any securities market in Hong Kong or overseas nor does he hold any position with the Company and its subsidiaries. He does not have relationships with any directors, senior management, substantial or controlling shareholders of the Company for the purpose of the Listing Rules. As at the Latest Practicable Date, Mr. Pike does not have any interests in shares of the Company within the meaning of Part XV of the SFO.

Mr. Pike's remuneration is fixed at HK\$150,000 per annum, which is commensurate with his duties and responsibilities as INED and member of audit committee, remuneration committee and nomination committee and approved by the Board with reference to the prevailing market situation for similar appointment. As a director of the Company, Mr. Pike is subject to retirement by rotation and re-election at annual general meetings in accordance with the bye-laws of the Company.

Mr. Pike has met the independence guidelines set out in Rule 3.13 of the Listing Rules and he has also given an annual confirmation of his independence to the Company this year. Mr. Pike has served in this capacity for more than nine years. Notwithstanding his long-term service, given his extensive economic and accounting experience, the nomination committee and the Board are of the opinion that he continues to bring independent and objective perspectives to the Company's affairs. The Board and the nomination committee also believes that Mr. Pike should be elected because he continues to bring relevant accounting experience and knowledge to the Board.

Save as disclosed above, the Board is not aware of any other matters or information that need to be brought to the attention of shareholders of the Company or to be disclosed pursuant to Rule 13.51(2) (h) to (v) of the Listing Rules in relation to the proposed re-election of the aforesaid retiring directors.

#### 5. RESPONSIBILITY STATEMENT

This circular, for which the directors of the Company collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. This Appendix I serves an explanatory statement, as required by the Listing Rules, to provide requisite information to Shareholders of the Company for their consideration as to whether to vote for or against the ordinary resolution to be proposed at the 2018 Annual General Meeting for granting the Repurchase Mandate.

This explanatory statement contains all the information required pursuant to rule 10.06 of the Listing Rules which is set out as follows:-

#### **SHARE CAPITAL**

As at the Latest Practicable Date, the Company has in issue an aggregate of 230,076,062 shares of HK\$0.10 each which are fully paid.

Subject to the passing of the ordinary resolution no. 6 as set out in the notice of 2018 Annual General Meeting and in accordance with the terms therein, the Company would be allowed under the Repurchase Mandate to repurchase fully paid shares up to the aggregate nominal amount of a maximum of 23,007,606 shares on the basis that no further shares will be issued or repurchased prior to the 2018 Annual General Meeting.

#### REASONS FOR SHARE REPURCHASE

Although the Directors have no present intention of repurchasing any shares of the Company, they believe that the flexibility afforded by the Repurchase Mandate would be beneficial to the Company and its Shareholders. Trading conditions on the Stock Exchange have sometimes been volatile. At any time in the future when Shares are trading at a discount to their underlying value, the ability of the Company to repurchase shares will be beneficial to those Shareholders who retain their investment in the Company since their interests in the assets of the Company would increase in proportion to the number of shares repurchased by the Company and thereby resulting in an increase in net asset value and/or earnings per share of the Company. Such repurchases will only be made when the Directors believe that the repurchases will benefit the Company and its Shareholders as a whole.

#### **FUNDING OF REPURCHASES**

The Company is empowered by its memorandum of association and bye-laws to repurchase its shares. In repurchasing shares, the Company may only apply funds legally available for such purpose in accordance with its memorandum of association and bye-laws and the applicable laws of Bermuda. In repurchasing shares, the Directors will only apply funds out of the capital paid up on the relevant shares or the funds of the Company which would otherwise be available for dividend or distribution or the proceeds of a fresh issue of Shares made for the purpose in accordance with Bermuda laws. Regarding the amount of premium (if any) payable on a repurchase, the Directors will only apply funds of the Company which would otherwise be available for dividend or distribution or out of the share premium account of the Company. The Shares so repurchased will be cancelled but the aggregate amount of authorized share capital will not be reduced.
