### **1. INTRODUCTION**

The Company's existing general mandates to issue shares and to repurchase shares were approved by the Company in the annual general meeting held on 21st May 2009. Unless otherwise renewed, the existing general mandates to issue shares and to repurchase shares will lapse at the conclusion of the 2010 Annual General Meeting.

## LETTER FROM THE BOARD OF DIRECTORS

In order to ensure flexibility when it is desirable to allot additional shares or to repurchase shares, the directors of the Company (the “**Directors**”) will seek the approval of shareholders to grant new general mandates to issue shares and to repurchase shares at the 2010 Annual General Meeting.

The purpose of this circular is to, inter alia, provide you with information on the proposed renewal of the general mandates to issue shares and to repurchase shares and on the retiring directors to be re-elected at the 2010 Annual General Meeting, so as to seek your approval of the related ordinary resolutions at the aforesaid meeting.

### **2. GENERAL MANDATE TO ISSUE SHARES (THE “ISSUE MANDATE”)**

Two ordinary resolutions, as set out in the notice of the 2010 Annual General Meeting, will be proposed for the following purposes:–

Ordinary resolution no. 4 – to grant to the Directors a general mandate to issue new shares up to a maximum of 20% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing of the resolution; and

Ordinary resolution no. 6 – to increase the aggregate nominal amount of share capital of the Company which the Directors may issue under the general mandate if given in the Ordinary Resolution no. 4 by the aggregate nominal amount of share capital of the Company repurchased under the general mandate if given in the ordinary resolution no. 5.

The Company has in issue an aggregate of 215,444,062 shares of HK\$0.10 each as at 26th March 2010, (the “**Latest Practicable Date**”), being the latest practicable date before the printing of this circular for ascertaining certain information to be included herein. Subject to the passing of the aforesaid ordinary resolution no. 4 and in accordance with the terms therein, the Company would be allowed to issue additional shares up to the aggregate nominal amount of a maximum of 43,088,812 shares on the basis that no further shares will be issued or repurchased prior to the 2010 Annual General Meeting.

### **3. GENERAL MANDATE TO REPURCHASE SHARES (THE “REPURCHASE MANDATE”)**

The ordinary resolution no. 5 as set out in the notice of the 2010 Annual General Meeting, will be proposed to grant to the Directors a general mandate to exercise the powers of the Company to repurchase the Company’s fully paid up shares representing up to a maximum of 10% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing of the resolution.

The Rules Governing the Listing of Securities on the Stock Exchange (the “**Listing Rules**”) contain provisions to regulate the repurchase by companies with primary listings on the Stock Exchange of their own securities on the Stock Exchange.

In accordance with the Listing Rules, the appendix to this circular serves as the explanatory statement, to provide you with the requisite information reasonably necessary to enable you to make an informed decision on whether to vote for or against the ordinary resolutions for granting of the Repurchase Mandate.

#### 4. INFORMATION OF THE RETIRING DIRECTOR TO BE RE-ELECTED AT THE 2010 ANNUAL GENERAL MEETING

**Mr. Lee, Sou Leung, Joseph** (“Mr. Lee”), aged 66, was appointed as an executive director of the Company since 10th July 2003. He is the founder and the managing director of the Company and its subsidiaries (the “Group”) and the chairman of the board of directors (“Board”), who is responsible for the strategic planning, business development and overall management of the Group. Mr. Lee has over 40 years of experience in the distribution of machines tools, advanced equipment and industrial products. Mr. Lee graduated from Wan Yah College, Hong Kong and Hong Kong Technical College (Certificate in Production Engineering), which was subsequently renamed as the Hong Kong Polytechnic University. Save as disclosed above, Mr. Lee did not hold any other directorships in the last three years in public companies the securities of which are listed on any securities market in Hong Kong or overseas. He is the director of certain subsidiaries of the Group.

Mr. Lee has entered into a service agreement with the Company for a term of three years commencing from 10th July 2003 and his appointment would continue thereafter unless and until terminated by either party in accordance with his service agreement. As a director, Mr. Lee is subject to retirement by rotation and re-election at annual general meetings in accordance with the Bye-laws of the Company. Mr. Lee’s existing remuneration is HK\$1,513,000 per annum. In addition, for each completed year of service, Mr. Lee is entitled to a bonus equal to one month’s average salary, and a discretionary bonus as may be decided by the board of directors of the Company in accordance with the terms of his service agreement with the Company. Mr. Lee’s remuneration, which is commensurate with his duties and responsibilities held, is approved by the Board with reference to the prevailing market situation for similar appointment. He has already received HK\$1,365,000 for salary and HK\$63,000 for retirement fund in the financial year 2009.

Mr. Lee is the spouse of Ms. Tan, Lisa Marie, an executive director of the Company, and the substantial shareholder of the Company. As at the Latest Practicable Date, Mr. Lee is interested in 148,213,982 shares of the Company and also holds share options to subscribe for a total of 500,000 shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance (“SFO”). Save as disclosed, he does not have other relationships with any directors, senior management or other substantial or controlling shareholder of the Company for the purpose of the Listing Rules and does not have any interests in shares of the Company within the meaning of Part XV of the SFO.

**Dr. Lui Sun Wing** (“Dr. Lui”), aged 59, has been appointed as independent non-executive director (“INED”) since 7th May 2003. Under his letter of appointment with the Company, his appointment is for a term of one year and may be extended thereafter for such period as the Company and Dr. Lui may agree in writing.

Dr. Lui was a branch director of the Hong Kong Productivity Council, responsible for overseeing the materials and process branch. He joined the Hong Kong Polytechnic University as vice president in 2000, and is now responsible for partnership development. He is also the chief executive officer of the institute of Enterprise of the Hong Kong Polytechnic University, the PolyU Technology and Consultancy Co. Ltd. and the PolyU Enterprises Limited. Dr. Lui is also a director of Advance New Technology Limited, a non-executive director of ECO-Teh Holdings Limited. He was the INED of 3D-Gold Jewellery Holdings Limited (Stock Code: 870) and Smart Union Group (Holdings) Limited (Stock Code: 2700) but had resigned on 7th November 2008 and 27th October 2008 respectively and is currently the INED of EVA Precision Industrial Holdings Limited (Stock Code: 838). As at the Latest Practicable Date, he did not hold any other directorships in the last three years in public companies the securities of which are listed on any securities market in Hong Kong or overseas. Dr. Lui does not hold any other position with the Company and its subsidiaries. He does not have relationships with any directors, senior management, substantial or controlling shareholders of the Company for the purpose of the Listing Rules.

As at the Latest Practicable Date, Dr. Lui holds share options to subscribe for a total of 100,000 shares of the Company within the meaning of Part XV of the SFO.

Dr. Lui's remuneration is fixed at HK\$100,000 per annum, which is commensurate with his duties and responsibilities as INED and the prevailing market situation. As a director of the Company, Dr. Lui is subject to retirement by rotation and re-election pursuant to the Bye-laws of the Company.

Save as disclosed above, the Board is not aware of any other matters or information that need to be brought to the attention of shareholders of the Company or to be disclosed pursuant to Rule 13.51(2) (h) to (v) of the Listing Rules in relation to the proposed re-election of the aforesaid retiring directors.

### **5. ACTION TO BE TAKEN**

### 6. RECOMMENDATION

Meanwhile, the Directors recommend that all shareholders should vote in favour of the related ordinary resolutions to be proposed at the 2010 Annual General Meeting.

This appendix serves an explanatory statement, as required by the Listing Rules, to provide requisite information to shareholders of the Company for their consideration as to whether to vote for or against the ordinary resolution to be proposed at the 2010 Annual General Meeting for granting the Repurchase Mandate.

This explanatory statement contains all the information required pursuant to rule 10.06 of the Listing Rules which is set out as follows:–

### **SHARE CAPITAL**

As at the Latest Practicable Date, the Company has in issue an aggregate of 215,444,062 shares of HK\$0.10 each which are fully paid.

Subject to the passing of the ordinary resolution no. 5 as set out in the notice of 2010 Annual General Meeting and in accordance with the terms therein, the Company would be allowed under the Repurchase Mandate to repurchase fully paid shares up to the aggregate nominal amount of a maximum of 21,544,406 shares on the basis that no further shares will be issued or repurchased prior to the 2010 Annual General Meeting.

### **REASONS FOR SHARE REPURCHASE**

Although the Directors have no present intention of repurchasing any shares of the Company, they believe that the flexibility afforded by the Repurchase Mandate would be beneficial to the Company and its shareholders. Trading conditions on the Stock Exchange have sometimes been volatile. At any time in the future when shares are trading at a discount to their underlying value, the ability of the Company to repurchase shares will be beneficial to those shareholders who retain their investment in the Company since their interests in the assets of the Company would increase in proportion to the number of shares repurchased by the Company and thereby resulting in an increase in net asset value and/or earnings per share of the Company. Such repurchases will only be made when the Directors believe that the repurchases will benefit the Company and its shareholders as a whole.

### **FUNDING OF REPURCHASES**

The Company is empowered by its memorandum of association and bye-laws to repurchase its shares. In repurchasing shares, the Company may only apply funds legally available for such purpose in accordance with its memorandum of association and bye-laws and the applicable laws of Bermuda. In repurchasing shares, the Directors will only apply funds out of the capital paid up on the relevant shares or the funds of the Company which would otherwise be available for dividend or distribution or the proceeds of a fresh issue of shares made for the purpose in accordance with Bermuda laws. Regarding the amount of premium (if any) payable on a repurchase, the Directors will only apply funds of the Company which would otherwise be available for dividend or distribution or out of the share premium account of the Company. The shares so repurchased will be treated as cancelled but the aggregate amount of authorized share capital will not be reduced.

**REPURCHASES MADE BY THE COMPANY**

Neither the Company nor any of its subsidiaries has purchased any of the Company's shares (whether on the Stock Exchange or otherwise) in the six months immediately preceding the Latest Practicable Date.

**POSSIBLE MATERIAL ADVERSE IMPACT**

There might be material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited accounts for the year ended 31st December 2009) in the event that the Repurchase Mandate was to be carried out in full at any time during the proposed repurchase period. However, the Directors do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the Company's working capital requirements or the gearing levels. The number of shares to be repurchased on any occasion and the price and other terms upon which the same are repurchased will be decided by the Directors at the relevant time having regard to the circumstances then pertaining.

**DIRECTORS' UNDERTAKING**

The Directors have undertaken to the Stock Exchange to exercise the powers of the Company to make repurchases under the Repurchase Mandate in accordance with the Listing Rules and laws of Bermuda and in accordance with the regulations set out in the memorandum of association and bye-laws of the Company.



## EFFECT OF HONG KONG CODE ON TAKEOVERS AND MERGERS

If as a result of share repurchase by the Company, a substantial shareholder's proportionate interest in voting rights of the Company increases, such increase will be treated as an acquisition for the purpose of the Hong Kong Code on Takeovers and Mergers (the "Code"). Accordingly, a shareholder, or group of shareholders acting in concert, could, depending on the level of increase in the interest of shareholdings, obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 and 32 of the Code.

As at the Latest Practicable Date and to the best of knowledge and belief of the Company, the following person(s) were directly or indirectly interested in 5% of more of the nominal value of the ordinary shares that carry a right to vote in all circumstances at general meetings of the Company:–

Note 1: The 2,868,000 shares are held by Mr. Lee as personal interests.

Note 2: The 144,529,982 shares are held by Peak Power Technology Limited in its capacity as the trustee of The Lee Family Unit Trust holding the same for the benefit of holders of units issued by The Lee Family Unit Trust. HSBC International Trustee Limited is the trustee of the LMT trust whose discretionary objects are Ms. Tan, and Mr. Lee's family members.

Note 3: These 816,000 shares are beneficially owned by Ms. Tan. As husband of Ms. Tan, Mr. Lee is deemed to be interested in these shares by virtue of family interests.

Note 4: Ms. Tan is deemed to be interested in shares held by Mr. Lee.

Note 5: Each of Mr. Lee and Ms. Tan holds share options to subscribe for 500,000 shares of the Company.

In the event that the Company exercised in full the power to repurchase shares of the Company in accordance with the terms of the ordinary resolution no. 5 to be proposed at the 2010 Annual General Meeting, the aforesaid interests of Mr. Lee, Ms. Tan and their respective associates in the existing issued share capital of the Company would be proportionally increased to approximately 76.44% (If both Mr. Lee and Ms. Tan exercise all their share options, such interest will further increase to 76.56% provided that the Repurchase Mandate is exercised in full.) Mr. Lee, Ms. Tan and their respective associates currently holds 68.79% of the issued share capital as at the Latest Practicable Date. As at the Latest Practicable Date, the Directors are not aware of the consequences of such increases or as a result of repurchases of shares that would result in any of the aforesaid persons or any shareholder, or group of shareholders acting in concert, becoming obliged to make a mandatory offer under the Code.

As at the Latest Practicable Date, although the exercise of the Repurchase Mandate in whole will result in less than 25% of the issued share capital of the Company being held by the public but the Directors have no intention to exercise the Repurchase Mandate to such an extent that would result in the number of shares in the hands of public falls below the prescribed minimum percentage of 25%.

#### **DIRECTORS' DEALINGS**

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, any of their associates presently intends to sell shares to the Company under the Repurchase Mandate in the event that such mandate as proposed in the ordinary resolution no. 5 is approved by the shareholders of the Company.

#### **CONNECTED PERSONS**

The Company has not been notified by any connected persons of the Company that they have a present intention to sell any shares to the Company, or that they have undertaken not to sell any shares held by them to the Company in the event that such mandate as proposed in the ordinary resolution no. 5 is approved by the shareholders of the Company.
