Executive Directors

Mr. Huang Ying Yuan, aged 48, is a founding member and the chairman and president of the Group. Mr. Huang has 22 years of experience in the infant products industry. Mr. Huang oversees the strategic planning and daily operations of the Group and has particular responsibility for marketing. Mr. Huang is the husband of Mrs. Huang Chen Li Chu, an executive director.

Mr. Tsang Yat Kiang, aged 50, is a founding member and vice chairman of the Group. Prior to the establishment of the Group, Mr. Tsang owned a trading business, which dealt mainly in machinery and equipment. Mr. Tsang is in charge of the strategic planning and finance of the Group.
