Pursuant to Rule 14A.12(1)(b) of the Listing Rules, the Trustee (in its capacity as trustee of the Trust) is an associate of connected persons of the Company. Therefore, the Company's payments to the Trustee of the Referable Amount to purchase Shares under the RS Scheme constitute continuing connected transactions of the Company under Chapter 14A of the Listing Rules.

The Board has resolved to adopt the Number Annual Cap of 9,000,000 Shares and the Referable Amount Annual Cap of HK\$900,000,000 for the Restricted Grant Period. As the applicable percentage ratios set out in the Listing Rules in respect of such Annual Caps for the continuing connected transactions under the RS Scheme are all less than 5%, the transactions are subject to the reporting, announcement and annual review requirements and are exempt from approval by the independent Shareholders under the Listing Rules.

SETTING OF ANNUAL CAPS

As disclosed in the 2019 Announcement, as the Trustee (in its capacity as trustee of the Trust) has become an associate of connected persons of the Company on 19 September 2019, the Company's payments to the Trustee of the Referable Amount to purchase Shares from the open market pursuant to the RS Scheme Rules and the transactions contemplated thereunder (the "Relevant Transactions") constitute connected transactions of the Company under Chapter 14A of the Listing Rules.

As the Company may make payments to the Trustee for purchase of Shares in 2023 to satisfy vesting of Restricted Shares under the RS Scheme, the Board has resolved to adopt the Annual Caps for the payment of the Referable Amount and the purchase of Shares for the Restricted Grant Period. Save for the setting of Annual Caps, all the other terms of the RS Scheme as disclosed in the Company's announcement dated 14 July 2016 shall remain unchanged and continue to be in effect.

Restricted Grant Period

The effective period of the Annual Caps which commences on 1 January 2023 and shall continue in force until 31 December 2023.

As disclosed in the 2019 Announcement, the aggregate interest of the Company's connected persons under the RS Scheme was approximately 57.05% following the grant of the Restricted Shares on 19 September 2019. As such, pursuant to Rule 14A.12(1)(b) of the Listing Rules, the Trustee (in its capacity as trustee of the Trust) has become an associate of connected persons of the Company, and the Relevant Transactions shall constitute connected transactions of the Company under Chapter 14A of the Listing Rules.

Given that the Administration Committee may from time to time pay the Referable Amount to the Trustee for the purchase of Shares under the RS Scheme, the Relevant Transactions contemplated under such payments of the Referable Amount constitute continuing connected transactions and the Company is required to comply with Chapter 14A of the Listing Rules for each payment of the Referable Amount. The setting of the Annual Caps provides a single basis on which the Company complies with the reporting and announcement requirements in compliance with the Listing Rules and thereby reduce the administrative burden and costs on the Company in relation to the payments of the Referable Amount during the Restricted Grant Period.
