- (2) to receive the printed English version of all future Corporate Communications by post only; or
- (3) to receive the printed Chinese version of all future Corporate Communications by post only; or
- (4) to receive both the printed English and Chinese versions of all future Corporate Communications by post.

If the Company does not receive the enclosed reply form or receive an objection from you on or before 26 September 2023, you will be deemed to have agreed to receive the Website Version, instead of printed copies, for all future Corporate Communications, until you inform us otherwise by reasonable prior notice in writing or by email to <u>liningecom@computershare.com.hk</u>. A printed notification letter of the publication of the Corporate Communications on the Company's website will be sent to you in the future.

Even if you elect the Website Version, you have the rights at any time to change your choice of language and means of receipt by sending reasonable prior notice in writing to the Company's Hong Kong Share Registrar. You may also send such notice by e-mail to <u>liningecom@computershare.com.hk</u>. If you have difficulties in receiving or gaining access to the Website Version of the Corporate Communication, the Company will upon your request in writing or by email send the printed versions of the Corporate Communications to you free of charge as soon as possible.
