PROFIT WARNING

This announcement is made by Link Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the Growth Enterprise Market (“**GEM**”) of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Director**”) of the Company wishes to inform shareholders of the Company (the “**Shareholders**”) and potential investors that, based on the information currently available to the Board and the unaudited consolidated management accounts of the Group for the nine months ended 30 September 2014 the Group is expected to record a significant decline of about 90% in profit for the nine months ended 30 September 2014 as compared to the corresponding period in 2013. The decline was primarily attributable to (i) the non-recurring expenses in connection with the listing of the shares of the Company on the GEM; (ii) the absence of interest income received from a company controlled by our controlling Shareholders; and (iii) slightly decrease in the revenue of about 9% due to the drop in occupancy rate and average room rate. If the non-recurring listing expenses and interest income are not taken into account, it is expected that the Group would record a decrease in profit of about 13% for the nine months ended 30 September 2014 as compared to the same period last year.

The Company is still in the process of finalising the third quarterly results of the Group for the nine months ended 30 September 2014. The information contained in this announcement is only based on the preliminary assessment made by the Board with reference to the unaudited consolidated management accounts for the nine months ended 30 September 2014 and information currently available to the Board which has not been audited or reviewed by the auditors or audit committee of the Company and is subject to possible adjustments upon further review.

Details of the Group’s financial information and performance will be disclosed in the third quarterly results announcement of the Company for the nine months ending 30 September 2014 which is expected to be published on 12 November 2014.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
