## SAME STORE SALES GROWTH ("SSSG")\* FOR 4Q OF FY2016

Remarks:

SSSG\* Same store sales growth of the period represented a comparison of sales of the same self-operated shop having full day operations in the comparable periods and such data did not include sales of licensed shops and Mainland China's e-commerce business.

With the overall sluggish retail sentiment, the SSSG\* of the Group's retail business for 4Q FY2016 was -27%, a slightly extended drop against the -25% in the third quarter. The SSSG\* of the Mainland China ("Mainland") market for 4Q FY2016 was -19% while the SSSG\* of its gem-set jewellery products managed to record a positive growth of 4%. The SSSG\* of the Hong Kong & Macau market was -28%.

## NUMBER OF SHOPS

As at 31 March 2016, the Group had a total of 168 Luk Fook self-operated shops which included 105 shops in Mainland, 47 shops in Hong Kong, 10 shops in Macau and 6 shops overseas. Together with 1,260 licensed shops in Mainland, there were a total of 1,428 Luk Fook shops worldwide, of which 1,365 shops were located in Mainland, as at the same date which are summarised as follows :-
