Lukfook Jewellery Extends Worldwide Retail Presence to Over 1,000 Retail Outlets Across Mainland China, HK, Macau, Singapore, US and Canada

At present, the total number of retail outlets in Mainland China is 1,022, spanning across 250 cities and autonomous regions such as Haikou City of Hainan Province in the South and Hulun Buir of Inner Mongolia Province in the North in 31 provinces. The Group's strong retail network is developed from Beijing, Shanghai, Guangzhou, Shenzhen and Wuhan to the neighboring regions, which offers premium quality of products and services to more than 1.3 billion customers in Mainland China.

According to the figures of Census and Statistics Department, the value of total retail sales in 2012 was HK\$445.4 billion, increased by 9.8% in value over 2011. Comparing the whole year of 2012 with 2011, the volume of sales of jewellery, watches and clocks, and valuable gifts increased by 2.4%. At present, the Group has totally 36 outlets in Hong Kong. The Group has been actively expanding its points of sale to the districts along the railway recently to further sustain its market share. Moreover, the Group has 9 outlets in Macau and 4 outlets in overseas market.

Mr. Wong Wai Sheung concluded, "Looking ahead, the Group is confident in Mainland China market, and will further explore other potential provinces and cities in order to accelerate our expansion plan and further boost the revenue and profit generated from Mainland China market.
