## LEGAL PROCEEDINGS AGAINST DIRECTORS OF GUANGZHOU MAYER

("Guangzhou Mayer") and Guangzhou Mayer for a conspiracy to usurp the absolute controlling and operation management rights of the Company over Guangzhou Mayer during the year of 2014 through a series of actions, breaching the integrity and duties as the directors and agents, under an action number HCA 1994/2016 (the "Legal Proceedings").

  - (3) the 1<sup>st</sup> Defendant to the 5<sup>th</sup> Defendant shall report the benefits obtained by them as the result of breaching of their directors' duties, including to return the directors' remuneration.
