PROPOSALS FOR GENERAL MANDATE TO ISSUE SECURITIES AND RE-ELECTION OF DIRECTORS AND NOTICE OF ANNUAL GENERAL MEETING

1. INTRODUCTION

The purpose of this circular is to provide you with information regarding resolutions to be proposed at the Annual General Meeting relating to, among other things, (i) the re-election of Directors; and (ii) the granting to the Directors of general mandate to issue securities of the Company up to 20% of the total number of Shares in issue as at the date of the passing of such resolution.

2. RE-ELECTION OF DIRECTORS

As at the Latest Practicable Date, the Board consists of eight (8) Directors, namely Mr. Chung Yin Shu, Frederick, Mr. Tsang On Yip, Patrick, Mr. Chung Wai Shu, Robert, Mr. Wong Tak Wai, Alvin, Mr. Lo Pak Shiu, Mr. Yuen Sik Ming, Patrick, Mr. Wong Kai Tung, Tony and Ms. Ling Kit Sum, Imma.

Pursuant to Article 103(A) of the Articles of Association, at each annual general meeting, one-third of the Directors for the time being, or, if their number is not three (3) or a multiple of three (3), then the number nearest one-third, shall retire from office. The Directors to retire in every year shall be those who have been longest in office since their last election but as between persons who became Directors on the same day those to retire shall (unless they otherwise agree between themselves) be determined by lot. The retiring Directors shall be eligible for re-election. Pursuant to Article 94 of the Articles of Association, the Board shall have power from time to time and at any time to appoint any person as a Director either to fill a casual vacancy or as an addition to the Board. Any Director so appointed shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re-election, but shall not be taken into account in determining the Directors who are to retire by rotation at such meeting.

Pursuant to Article 103(A) of the Articles of Association, Mr. Chung Yin Shu, Frederick and Mr. Wong Kai Tung, Tony shall retire from office by rotation and, being eligible, offer themselves for re-election at the Annual General Meeting. In addition, Mr. Wong Tak Wai, Alvin and Ms. Ling Kit Sum, Imma, being Directors appointed by the Board in May 2023, shall hold office until the Annual General Meeting pursuant to Article 94 of the Articles of Association and, being eligible, offer themselves for re-election as Directors. Their proposed re-election will be considered by separate resolutions.

Details of the above retiring Directors who are proposed to be re-elected at the Annual General Meeting (the "**Retiring Directors**") are set out in Appendix to this circular.

The Nomination Committee of the Company (the "Nomination Committee") has reviewed and is satisfied with the current structure, size and composition of the Board and the Board committees of the Company.

The Nomination Committee considered Mr. Wong Kai Tung, Tony and Ms. Ling Kit Sum, Imma, both being Independent Non-Executive Directors, who will be subject to retirement and re-election at the Annual General Meeting (the "Retiring INEDs") with in-depth understanding of the Company's operations and business, they have expressed objective views and given independent guidance to the Company, and they continue demonstrating a firm commitment to their role. The Nomination Committee is satisfied that they have the required character, integrity, independence and experience to continue fulfilling the role of Independent Non-Executive Directors. They are beneficial to the Board with diversity of their comprehensive business experience that contribute to invaluable expertise in legal, accounting, auditing, due diligence and initial public offerings, continuity and stability to the Board. The Nomination Committee

believes that they will continue to contribute effectively to the Board with their respective perspectives, skills and experience.

In addition, none of the Retiring INEDs has any financial or family relationships with any other Directors, senior management, substantial shareholders or controlling shareholders of the Company, which could give rise to a conflict of interests situation or otherwise affect their exercise of independent judgement. Furthermore, each of the Retiring INEDs has made a confirmation of independence pursuant to the independence guidelines set out in Rule 3.13 of the Listing Rules. Taking into consideration of the above, the Nomination Committee and the Board are of the view that all the Retiring INEDs are independent.

In view of the above, the Nomination Committee believes that the re-election of the Retiring Directors (including the Retiring INEDs) at the Annual General Meeting is in the best interests of the Company and the Shareholders as a whole and has agreed to nominate them to the Board for re-election at the Annual General Meeting. In addition, given the knowledge, skills, experience and diversity aspects (including without limitation to gender, age, cultural, educational background and professional experience) of the Retiring Directors (including the Retiring INEDs) and their valuable contributions to the Company over the years, the Board also considers that the re-election of the Retiring Directors (including the Retiring INEDs) is in the best interests of the Company and the Shareholders as a whole. The Board has therefore accepted the nomination by the Nomination Committee to recommend the Retiring Directors (including the Retiring INEDs) to stand for re-election by the Shareholders at the Annual General Meeting.

3. GENERAL MANDATE TO ISSUE SECURITIES

At the annual general meeting of the Company held on 20 January 2023, ordinary resolution was passed for the granting of general mandate to the Directors to allot, issue and deal with additional shares of the Company up to 20% of the total number of Shares in issue as at that date ("Existing Issue Mandate"), being 5,000,000 Shares.

The Existing Issue Mandate will expire upon the conclusion of the Annual General Meeting. The Directors consider that the Existing Issue Mandate increases the flexibility in dealing of the Company's affairs and is in the interests of both the Company and the Shareholders as a whole, and that the same shall continue to be adopted by the Company.
