Miramar Tower is held by the Group as an investment for rental purposes. The Directors (including the independent non-executive Directors) are of the opinion that the New Lease was entered into (i) in the ordinary and usual course of business of the Group; (ii) on normal commercial terms; and (iii) on terms that are fair and reasonable and in the interests of the Company and its shareholders as a whole.

The terms of the New Lease were determined after arm's length negotiations between the parties and the rent is determined by reference to market rental of the Premises endorsed by a valuation certificate dated 20 December 2012 by DTZ Debenham Tie Leung Limited, an independent valuer. The other terms of the New Lease were determined with reference to a standard tenancy agreement which was also used in relation to other leases with other tenants of Miramar Tower.
