**FURTHER EXTENSION OF THE CONTRIBUTION EXPIRATION
DATE OF THE DISCLOSEABLE AND CONNECTED TRANSACTION
IN RELATION TO THE EQUITY TRANSFER AGREEMENT**

References are made to the announcement of the Regal International Airport Group Company Limited (the “**Company**”) dated 13 November 2015, the circular of the Company dated 4 December 2015, the extension announcement of the Company dated 29 September 2017 (the “**2017 Extension Announcement**”) and the extension announcement of the Company dated 29 March 2018 (the “**2018 Extension Announcement**”) in relation to, among other things, the Equity Transfer Agreement entered into between the Parent Company and the Company and the transactions contemplated thereunder. Terms defined in such announcements and circular shall have the same meanings when used herein, unless the context requires otherwise.

FURTHER EXTENSION OF THE CONTRIBUTION EXPIRATION DATE

As disclosed in the 2017 Extension Announcement, pursuant to the Equity Transfer Agreement, both parties unanimously agreed that in case that the Parent Company could not transfer all the contributed assets to the Target Company before 30 September 2017, or any later date as agreed by the Company in written (the “**Contribution Expiration Date**”), the Equity Transfer Agreement shall be void. The Company agreed in written to extend the Contribution Expiration Date from 30 September 2017 to 31 March 2018. As disclosed in the 2018 Extension Announcement, the Company agreed in written to further extend the Contribution Expiration Date from 31 March 2018 to 30 September 2018.

As additional time is required to complete the contribution of assets due to the continuous suspension of transfer procedures regarding the relevant land and buildings by relevant local government authorities according to the requirements of policies, the Company has agreed in written to further extend the Contribution Expiration Date from 30 September 2018 to 31 March 2019. Save for such extension, all other terms and conditions of the Equity Transfer Agreement shall remain unchanged and shall continue in full force and effect.
