But if more than one of such joint holders is present at the meeting, the vote of the senior who tenders a vote, whether in person or by proxy, shall be accepted to the exclusion of the votes of other joint holders and, for this purpose, seniority shall be determined by the order in which the names stand in the register of members of the Company in respect of the joint holding.
- This form of proxy must be signed by you or your attorney duly authorized in writing, or in the case of legal person, must be either under its seal or signed by a director
- or attorney duly authorized to sign the same.

  This form of proxy together with a notarially certified copy of the power of attorney or other authority, if any, must be lodged at the Company's H Share registrar, Computershare Hong Kong Investor Service Limited at Room 1806, 18th Floor, HOPEWILL CENTRE, 183 QUEEN'S ROAD EAST, HONG KONG not less than 24 hours before the time fixed for holding the meeting or any adjournment thereof.
