- 1. Full name(s) (in Chinese and English) and address(es) (as shown in the register of members) to be inserted in BLOCK LETTERS.
- 2. Please insert the number and class of shares registered in your name(s); if no number is inserted, this revised form of proxy will be deemed to relate to all such shares of the Company registered in your name(s).
- 3. If any proxy other than the chairman of the Domestic Shareholders Class Meeting is appointed, strike out "the chairman of the Domestic Shareholders Class Meeting or" and insert the name(s) and address(es) of the proxy/proxies desired in the spaces provided.
- 4. IMPORTANT: If you wish to vote for a resolution, please place a "\" in the box marked "FOR". If you wish to vote against a resolution, please place a "\" in the box marked "AGAINST". The shares abstained will not be counted in the calculation of the required majority. Failure to complete a box will entitle your proxy to cast your vote(s) at his discretion. Your proxy will also be entitled to vote at his discretion on any resolution (or any amendment thereto) properly put to the Domestic Shareholders Class Meeting other than those set out in the notice (the "Notice") and the supplemental notice (the "Supplemental Notice") convening the Domestic Shareholders Class Meeting.
- The resolution no. 1 shall be put forward as 13 separate resolutions.
- 6. In the case of joint holders of any shares in the Company, any one of such joint holders may vote, either in person or by proxy, in respect of such shares as if he were solely entitled thereto. But if more than one of such joint holders are present at the meeting, the vote of the senior who tenders a vote, whether in person or by proxy, shall be accepted to the exclusion of the votes of other joint holders and, for this purpose, seniority shall be determined by the order in which the names stand in the register of members of the Company in respect of the joint holding.
- 7. This revised form of proxy must be signed by you or your attorney duly authorized in writing, or in the case of legal person, must be either under its seal or signed by a director or attorney duly authorized to sign the same.
- For holders of domestic shares of the Company, this revised form of proxy together with a notarially certified copy of the power of attorney or other authority, if any, must be delivered to Secretary Office to the Board of the Company at Office Building of Median Airport, Haikou City, Hainan Province, the PRC, not less than 24 hours before the time fixed for holding the meeting or any adjournment thereof in order for such documents to be valid.
- 9. A proxy need not be a member of the Company but must attend the meeting in person to represent you
- 10. Completion and deposit of this revised form of proxy will not preclude you from attending and voting at the meeting if you so wish. In the event that you attend the meeting after having lodged this revised form of proxy, this revised form of proxy will be deemed to have been revoked.
- 11. Each alteration made to this revised form of proxy must be initialed by the person who signs it.
- 12. IMPORTANT: If you have not yet lodged the original form of proxy which was sent to you together with the Notice (the "Original Proxy Form") with the Company's Secretary Office, you are requested to lodge this revised form of proxy if you wish to appoint proxies to attend the Domestic Shareholders Class Meeting on your behalf. In this case, the Original Proxy Form should not be lodged with the Company's Secretary Office.
- 13. IMPORTANT: If you have already lodged the Original Proxy Form with the Company's Secretary Office, you should note that:
  - (i) If this revised form of proxy is not lodged with the Company's Secretary Office before the closing time as mentioned in point 8 above or if it is incorrectly completed, the Original Proxy Form will be treated as a valid proxy form lodged by you if correctly completed. The proxy so appointed by you will be entitled to vote at his or her discretion or to abstain on any resolution properly put to the Domestic Shareholders Class Meeting other than those referred to in the Notice and the Original Proxy Form, including the newly added resolutions as set out in the Supplemental Notice.
  - (ii) If you have lodged this revised form of proxy with the Company's Secretary Office before the closing time as mentioned in point 8 above, this revised form of proxy will revoke and supersede the Original Proxy Form previously lodged by you provided that this revised form of proxy is correctly completed.
