The Board is pleased to announce that all resolutions proposed at the AGM held on 27 April 2018 were duly passed by way of poll.

The Board also announces that Mr. Chen Yepern retired as an executive director of the Company and ceased to be a member of each of the Remuneration Committee, Nomination Committee and AML Oversight Committee of the Board at the conclusion of the AGM.

POLL RESULTS OF THE ANNUAL GENERAL MEETING

The board of directors (the “**Board**”) of NagaCorp Ltd. (the “**Company**”) is pleased to announce that all the resolutions proposed at the annual general meeting of the Company (the “**AGM**”) held on 27 April 2018 as set out in the notice of the AGM dated 16 March 2018 (the “**Notice**”) were duly passed by the shareholders of the Company (the “**Shareholders**”) by way of poll.

As at the date of the AGM, there were a total of 4,341,008,041 issued shares of the Company (the “**Shares**”) entitling the holders to attend and vote for or against all the proposed resolutions at the AGM. There were no Shares entitling the holders to attend and abstain from voting in favour at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

There were no Shares requiring the holders to abstain from voting on the proposed resolutions at the AGM under the Listing Rules. No Shareholders have stated their intention in the Company’s circular dated 16 March 2018 to vote against or abstain from voting on any of the proposed resolutions at the AGM.

The branch share registrar of the Company in Hong Kong, Computershare Hong Kong Investor Services Limited, was appointed and acted as the scrutineer for the vote-taking at the AGM.
