On 29 August 2016, a total of 28,100,000 share options were granted by the Company to certain eligible participants of Company under the share option scheme adopted by the Company on 29 January 2016.

Of the 28,100,000 share options, 8,500,000 share options were granted to the directors and 19,600,000 share options were granted to other employees of the Company and its subsidiaries.

As at 31 August 2016, 28,100,000 share options were outstanding but all of them remained unvested in accordance with the terms of the grant as disclosed in the Company's announcement dated 29 August 2016.
