Information of the Property

The Property is located at House No. 8 (including its carport on lower ground floor, its garden on ground floor and its main roof), Villa Rosa, No. 88 Red Hill Road, Hong Kong. The Property is a residential property with a gross floor area of 5,972 sq.ft..

Consideration and payment terms

The consideration for the Disposal of HK\$82,000,000 has been determined after arm's length negotiations between the parties by reference to the market value of the Property of HK\$81,000,000 as at 16 July 2007, being a value indication by an independent valuer, DTZ Debenham Tie Leung Limited. The Group currently intends to use the net proceeds from the Disposal of approximately HK\$67.8 million for repayment of bank loan and approximately HK\$13.3 million for general working capital of the Group.

The consideration for the Disposal shall be payable to the Vendor in cash in the following manner:

REASON FOR THE DISPOSAL

The Company is an investment holding company and its subsidiaries are principally engaged in the manufacture, assembly and sale of electronic watches and watch parts, trading of watch movements and watch parts, property development and investment. The Property was acquired by the Group in December 1999. It was initially used by the Group for rental purposes until May 2005. Since then, the Property has been vacant. The Directors consider that the Disposal provides an opportunity for the Group to realise the Property and provide working capital for the Group in view of the present property market in Hong Kong. The Directors consider that the disposal of the Property is in the interest of the Company and the terms of the Agreement are fair and reasonable as far as the Shareholders are concerned. The unaudited net loss both before and after taxation and extraordinary items attributable to the Property was approximately HK\$2.99 million for the year ended 31 March 2007.

The audited net loss both before and after taxation and extraordinary items attributable to the Property was approximately HK\$2.08 million for the year ended 31 March 2006.

As at 30 September 2006, the unaudited net book value of the Property was approximately HK\$46.11 million. Based on such net book value, a gain of approximately HK\$34.99 million is expected to accrue to the Group upon completion of the Agreement after taking into account of the related expenses payable by the Group of approximately HK\$0.9 million.
