Under Facility Agreement A, in the event the Shum Family cease to remain as the largest shareholder and maintains less than 30% shareholdings of the Company, the facility available to the Company will be cancelled and all outstanding amounts will then become immediately due and payable.

On 27 November 2013 the Company entered into Facility Agreement B for a bilateral term loan facility US\$20,000,000 (equivalent to approximately HK\$155,600,000) for the purpose of financing the general working capital requirements of the Group. The loan to be made to the Company upon utilization of the facility will be repayable in six quarterly instalments, commencing fifteen months after the date of first drawdown. Under Facility Agreement B, in the event the Shum Family cease to remain as the single largest shareholder of the Company, the facility available to the Company will

be cancelled and all outstanding amount will then become immediately due and payable.
