**UPDATE ON THE SETTLEMENT OF
THE CASH CONSIDERATION A FOR THE ACQUISITION
OF ENTIRE ISSUED SHARE CAPITAL OF GEAR WORLD

This announcement is made by National United Resources Holdings Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

Reference is made to the announcements of the Company dated 15 January 2016, 31 August 2016 and 14 February 2017 (the “**Announcements**”) and the circular (the “**Circular**”) of the Company to its shareholders dated 30 June 2016 in relation to, among other things, the Acquisition. Reference is also made to the poll results announcement of the Company’s general meeting dated 18 July 2016. Unless otherwise defined herein, terms used in this announcement shall have the same meaning as those defined in the Announcements and the Circular.

As disclosed in the Announcements, Vendor II agreed that the Cash Consideration A (after deducting the Advance Payment) payable to Vendor II may be settled by noon of 20 February 2017. As at the date of this announcement, the Cash Consideration A (after deducting the Advance Payment) has not been settled.

The Company and Vendor II are in discussions to resolve the settlement of the Cash Consideration A and the Company will keep the Shareholders updated on any material developments.
