POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 26 MAY 2017

The board of directors (the “**Board**”) of Oriental Explorer Holdings Limited (the “**Company**”) is pleased to announce that the proposed resolutions as set out in the notice of the annual general meeting dated 20 April 2017 (the “**AGM Notice**”) were taken by way of poll.

Tricor Tengis Limited, the Hong Kong branch share registrar of the Company, had acted as the scrutineer for the vote-taking at the annual general meeting held on 26 May 2017 (the “**2017 AGM**”).

The number of votes in the poll results represented votes cast by shareholders of the Company (the “**Shareholder(s)**”) who were attending and voting either in person, by proxy or by corporate representative.

As at the date of the 2017 AGM, the total number of issued shares of the Company (the “**Share(s)**”) was 2,700,000,000, which was the total number of Shares entitling the holders to attend and vote for or against all resolutions at the 2017 AGM. There were no shares entitling the holder to attend and abstain from voting in favour at the 2017 AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

No Shareholder was required under the Listing Rules to abstain from voting on the resolutions at the 2017 AGM. None of the Shareholders had stated their intention in the circular containing the AGM Notice to vote against or to abstain from voting on any of the resolutions at the 2017 AGM.
