ANNOUNCEMENT OF ALLOTMENT RESULTS

SUMMARY

- The fixed Offer Price is HK\$1.00 per Offer Share (excluding brokerage of 1.0%, SFC transaction levy of 0.0027% and the Stock Exchange trading fee of 0.005%).
- The Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. A total of 2,612 valid applications have been received pursuant to the Public Offer on **WHITE**, **YELLOW** or **PINK** Application Forms and through giving electronic application instructions to HKSCC via CCASS for a total of 1,012,492,000 Public Offer Shares, representing approximately 67.5 times of the 15,000,000 Offer Shares initially available for subscription under the Public Offer.
- Due to the very significant over-subscription in the Public Offer, the reallocation procedures as described in the paragraph headed “Basis of allocation of the Offer Shares” of the section headed “Structure and conditions of the Share Offer” of the Prospectus have been applied. As the number of Shares validly applied for under the Public Offer represents 50 times or more but less than 100 times of the number of Public Offer Shares, a total of 45,000,000 Offer Shares initially available under the Placing have been reallocated to the Public Offer and the final number of Offer Shares under the Public Offer has been increased to 60,000,000 Offer Shares (including the Employee Reserved Shares), representing 40% of the Offer Shares initially available under the Share Offer.
- 7 valid applications have been received pursuant to the Employee Preferential Offering on **PINK** Application Forms for a total of 660,000 Employee Reserved Shares, representing approximately 0.4 times of the 1,500,000 Employee Reserved Shares initially available for subscription under the Employee Preferential Offering. As the Employee Preferential Offering has been undersubscribed, a total of 840,000 unsubscribed Employee Reserved Shares have been reallocated to the Public Offer.
- The Offer Shares initially offered under the Placing have been moderately over-subscribed by approximately 3.3 times. As a result of the reallocation, the final number of Offer Shares under the Placing is 90,000,000 Shares, representing 60% of the Offer Shares initially available under the Share Offer.
- Based on the Offer Price of HK\$1.00 per Offer Share, the net proceeds from the Share Offer to be received by the Company after deducting underwriting fees and estimated expenses payable by the Company in connection with the Share Offer, is estimated to be approximately HK\$121.5 million. The Company intends to apply such net proceeds in the manner set out in the paragraph “Offer Price and Net Proceeds” below in this announcement.

OFFER PRICE AND NET PROCEEDS

The fixed Offer Price is HK\$1.00 per Offer Share (exclusive of brokerage of 1.0%, the SFC transaction levy of 0.0027% and the Stock Exchange trading fee of 0.005%).

Based on the Offer Price of HK\$1.00 per Share, the net proceeds from the Share Offer to be received by the Company after deducting underwriting fees and estimated expenses payable by the Company in connection with the Share Offer (the “**Net Proceeds**”), are estimated to be approximately HK\$121.5 million.

The Group intends to apply the Net Proceeds from the Share Offer for the following purposes:

- (i) approximately 67.2%, or HK\$81.7 million, will be used to partially fund phase two of construction of the Springfield production facilities;
- (ii) approximately 9.9%, or HK\$12.0 million, will be used for the purchase of additional machinery and equipment;
- (iii) approximately 2.7%, or HK\$3.3 million, will be used for partial settlement of the purchase price of the land for phase two of construction of the Springfield production facilities. Details of this transaction can be found in the section headed “Connected transactions” in the Prospectus;
- (iv) approximately 16.5%, or HK\$20.0 million will be used for repayment of a bank overdraft facility. Details of this facility are as follows:
 - We intend to withdraw HK\$20.0 million from an overdraft facility with no maturity date but is repayable on demand by the bank. Interest is expected to be charged at 2% per annum below the prime rate of the bank or at 3% per annum over HIBOR, whichever is higher.
 - The capital obtained from this facility will be used for the Group’s general working capital, including for the partial repayment of the shareholders’ loan by Mezzo; and
- (v) the remainder of approximately 3.7%, or HK\$4.5 million, will be used for working capital and other general corporate purposes.

APPLICATIONS UNDER THE PUBLIC OFFER AND THE EMPLOYEE PREFERENTIAL OFFERING

The Directors announce that the Public Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. At the close of the application lists at 12:00 noon on Friday, 20 November 2015, a total of 2,612 valid applications pursuant to the Public Offer on (i) **WHITE**, **YELLOW** and **PINK** Application Forms, and (ii) through giving electronic application instructions to HKSCC via CCASS, for a total of 1,012,492,000 Public Offer Shares were received, representing approximately 67.5 times the 15,000,000 Offer Shares initially available for subscription under the Public Offer.

Out of the 2,612 valid applications for a total of 1,012,492,000 Public Offer Shares:

- 2,605 valid applications for a total of 1,011,832,000 Offer Shares were for the Public Offer excluding the Employee Reserved Shares, representing approximately 75.0 times of the 13,500,000 Public Offer Shares initially available for subscription under the Public Offer, without taking into account the Employee Reserved Shares; and
- 7 valid applications for a total of 660,000 Offer Shares were for Employee Reserved Shares under the Employee Preferential Offering on **PINK** Application Forms, representing approximately 0.4 times of the 1,500,000 Employee Reserved Shares initially available for subscription under the Employee Preferential Offering. As the Employee Preferential Offering has been undersubscribed, a total of 840,000 unsubscribed Employee Reserved Shares have been reallocated to the Public Offer.

One application has been rejected due to a bounced cheque. Two applications were identified as suspected multiple applications and were therefore rejected. Save for the above, no applications which had not been completed in accordance with the instructions on the Application Forms and no application for more than 6,748,000 Public Offer Shares or 1,500,000 Employee Reserved Shares have been identified.

Due to the very significant over-subscription in the Public Offer, the reallocation procedures as described in the paragraph headed “Basis of allocation of the Offer Shares” of the section headed “Structure and conditions of the Share Offer” of the Prospectus have been applied. As the number of Offer Shares validly applied for under the Public Offer represents 50 times or more but less than 100 times of the number of Public Offer Shares, a total of 45,000,000 Offer Shares initially available under the Placing have been reallocated to the Public Offer and the final number of Offer Shares under the Public Offer has been increased to 60,000,000 Offer Shares (including the Employee Reserved Shares), representing 40% of the Offer Shares initially available under the Share Offer.

The Offer Shares offered in the Public Offer and the Employee Preferential Offering were conditionally allocated on the basis set forth in the paragraph “Basis of Allotment under the Public Offer and the Employee Preferential Offering” below in this announcement.

PLACING

The Placing has been moderately over-subscribed by approximately 3.3 times. As a result of the reallocation, the final number of Offer Shares under the Placing is 90,000,000 Shares, representing 60% of the Offer Shares initially available under the Share Offer.

The Directors confirm that no Offer Shares have been allocated to placees who are: (i) Directors, the chief executive officer or existing beneficial owners of Shares and/or any of the Company's subsidiaries; or (ii) core connected persons of the Company; or (iii) the close associates of (i) and/or (ii) whether in their own names or through nominees. The Placing is in compliance with the placing guidelines for equity securities as set out in Appendix 6 to the Listing Rules. None of the Sponsor and the Underwriters and their affiliated companies and the connected clients (as defined in Appendix 6 to the Listing Rules) has taken up any Offer Shares for its own benefits under the Share Offer. The Directors confirm that the three largest public Shareholders of the Company do not hold more than 50% of the Shares held in public hands at the time of the Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules. The Directors further confirm that none of the placees under the Placing will become a Substantial Shareholder (as defined under the Listing Rules) of the Company after the Share Offer, and the Company's public float will satisfy the minimum percentage prescribed under Rule 8.08 of the Listing Rules after the Placing. No placee will, individually, be placed with more than 10% of the enlarged issued share capital of the Company immediately after the Share Offer. As such, the Directors confirm that there will not be any new Substantial Shareholder immediately after the Share Offer, and the number of Shares in public hands will satisfy the minimum percentage as required under Rule 8.08 of the Listing Rules.
