Mr. Chen's office as the chairman of the Board and an executive Director has been vacated accordingly and Mr. Chen has also ceased to be the chief executive officer of the Company, the chairman of each of the nomination committee and the corporate governance committee of the Board and a member of the remuneration committee of the Board.

The Board has been informed that Mr. Chen intends to take all necessary actions to apply to the High Court of Hong Kong for an appeal against the bankruptcy proceedings, and to seek for re-appointment as a director of the Company.

The Board is of the opinion that the business of the Company will continue to operate normally following the vacation of Mr. Chen from his office as the chairman of the Board and an executive Director. The Board will select suitable candidate(s) to take over the position(s) of the chairman of the Board and the chief executive officer as soon as practicable.

The Board would like to take this opportunity to express its sincere gratitude to Mr. Chen for his valuable contributions to the Company during his tenure of office.
