ANNOUNCEMENT CONTINUING CONNECTED TRANSACTION

On 30 December 2013, Phoenix HK through Shenzhou entered into the 2014 Contract with CNHK Media. CNHK Media has entered into the 2014 Contract for the ultimate benefits of the CMCC Group.

The New Transactions constitute continuing connected transactions for the Company under Chapter 14A of the Listing Rules and are subject to the reporting and announcement requirements of the Listing Rules.

2014 CONTRACT

Reference is made to the announcement of the Company dated 31 December 2012 relating to the 2013 Contract. As the transactions contemplated under the 2013 Contract will expire on 31 December 2013 and CNHK Media would like to continue to purchase advertising airtime at and/or sponsoring programmes being broadcasted on the Phoenix Chinese Channel and the Phoenix InfoNews Channel operated by the Group thereafter, Phoenix HK through Shenzhou entered into the 2014 Contract with CNHK Media on 30 December 2013.

Pursuant to the 2014 Contract, CNHK Media shall purchase advertising airtime at and/or sponsoring programmes being broadcasted on the Phoenix Chinese Channel and the Phoenix InfoNews Channel respectively for the period from 1 January 2014 to 31 December 2014 for the sum not exceeding RMB75,000,000 (equivalent to approximately HK\$95,445,000) for promoting the CMCC Group. To the best of the Directors' knowledge, information and belief having made all reasonable enquiry, CNHK Media has entered into a contract with a subsidiary of CMCC in the PRC relating to and including the purchase of advertising airtime at and/or sponsoring programmes

being broadcasted on the Phoenix Chinese Channel and the Phoenix InfoNews Channel for the benefit and on behalf of the CMCC Group. As such, CNHK Media has entered into the 2014 Contract for the ultimate benefits of the CMCC Group.

Under the 2014 Contract, CNHK Media shall pay the advertising costs for New Transactions placed and confirmed by CNHK Media on or before 31 December 2013 by seven instalments: (a) the 1st instalment of 10% of the advertising costs as earnest deposit before 31 December 2013; (b) 2nd instalment of 25% of the advertising costs before 31 December 2013; (c) 3rd instalment of 15% of the advertising costs before 20 February 2014; (d) 4th instalment of 15% of the advertising costs before 18 April 2014; (e) 5th instalment of 15% of the advertising costs before 20 June 2014; (f) 6th instalment of 15% of the total advertising costs before 20 August 2014; and (g) 7th instalment of 15% of the advertising costs before 20 October 2014. The earnest deposit will be applied to partially set off against the amount of the 7th instalment payable by CNHK Media. For New Transactions placed and confirmed by CNHK Media after 31 December 2013, CNHK shall pay the advertising costs (i) in full upon signing individual contracts, if the broadcasting period of the sponsorship and/or advertisement is or within 31 days; and (ii) in the manners to be agreed by Shenzhou and CNHK Media under individual contracts, if the broadcasting period of the sponsorship and/or advertisement exceeds 31 days.

Shenzhou and CNHK Media, to the best of the Directors' knowledge, information and belief having made all reasonable enquiry, are independent third parties which are (i) not connected with any of the directors, chief executives, substantial shareholders of the Company or any of its subsidiaries or any of their respective associates; and (ii) not a connected person of the Company as defined in the Listing Rules.

REASONS FOR THE NEW TRANSACTIONS

Phoenix HK sells advertising airtime and program sponsorship on its satellite television channels in its ordinary course of business. Income from sale of advertising airtime and program sponsorship forms the major part of its turnover. By selling advertising airtime and program sponsorship to the CMCC Group indirectly through CNHK Media, Phoenix HK is able to generate more income for its operation and business.

The 2014 Contract was entered into by the parties after arm's length negotiation such that the advertising airtime and program sponsorship provided by Phoenix HK to other customers will be at rates no less favourable than that of the 2014 Contract. The contract sum under the 2014 Contract was agreed between the parties with reference to the rate card published by Phoenix HK from time to time which contains the pricing structure for the sale of advertising airtime and program sponsorship on its satellite television channels, the advertising airtime and program sponsorship purchased by CNHK Media in 2013, and the expected growth in the marketing and promotional activities of the CMCC Group for 2014.

The Directors, including the independent non-executive Directors, are of the view that the 2014 Contract was entered into in the ordinary and usual course of business of Phoenix HK and the terms thereof are normal commercial terms, and are fair and reasonable and in the interests of the Company and the Shareholders as a whole.

Three Directors of the Company, namely Mr. SHA Yuejia, Mr. GAO Nianshu and Dr. LO Ka Shui, have abstained from voting on the Board resolutions approving the 2014 Contract due to the fact that Mr. SHA Yuejia and Mr. GAO Nianshu are Directors nominated by a member of CMCC Group and Dr. LO Ka Shui is an independent non-executive director of China Mobile Limited. Save as disclosed above, none of the Directors has a material interest in the 2014 Contract.

IMPLICATIONS UNDER THE LISTING RULES

As CMHKG is a substantial shareholder of the Company holding approximately 19.67% issued share capital of the Company through its wholly-owned subsidiary, namely Extra Step Investments Limited, CMCC, being the ultimate holding company of CMHKG, is a connected person of the Company under the Listing Rules. The New Transactions constitute continuing connected transactions for the Company under Chapter 14A of the Listing Rules. As the assets ratio, revenue ratio and consideration ratio under the 2014 Contract are more than 0.1% but less than 5%, the New Transactions are subject to the reporting and announcement requirements of the Listing Rules.

GENERAL

The Group is a satellite television operator and, through its subsidiaries, is a leading satellite television operator broadcasting into the PRC.

CMHKG is the substantial shareholder of China Mobile Limited which is a leading mobile telecommunications service provider in the PRC, providing mobile telecommunications and related services in all 31 provinces, autonomous regions and directly-administered municipalities and in the PRC and in Hong Kong. The ordinary shares of China Mobile Limited are listed on the Stock Exchange and its American depositary shares are listed on the New York Stock Exchange.
