#### CONTINUING CONNECTED TRANSACTIONS OUTDOOR ADVERTISING CONTRACT

On 18 May 2017, PMM, a subsidiary of the Company, entered into the 2017 CMC Outdoor Advertising Contract with CMC for the period commencing from the Effective Date to 31 March 2018 for promoting the businesses of the CMC Group at a maximum contract sum not exceeding RMB13,130,000 (equivalent to approximately HK\$14,817,205).

The Transactions constitute continuing connected transactions for the Company under Chapter 14A of the Listing Rules. As the applicable percentage ratios for the maximum contract sum under the 2017 CMC Outdoor Advertising Contract, MIGU Advertising Contract, the CMGG Advertising Contract, the 2016 CMGD Outdoor Advertising Contract and the 2016 CMC Outdoor Advertising Contract calculated on an aggregate basis exceed 0.1% but are less than 5%, the 2017 CMC Outdoor Advertising Contract and the Transactions are subject to reporting, announcement and annual review requirements but are exempt from the independent shareholders' approval requirements under Chapter 14A of the Listing Rules.

#### INTRODUCTION

The Board is pleased to announce that on 18 May 2017, PMM has entered into the 2017 CMC Outdoor Advertising Contract with CMC.

#### THE 2017 CMC OUTDOOR ADVERTISING CONTRACT

Pursuant to the 2017 CMC Outdoor Advertising Contract, CMC may place advertisements on the outdoor LED Panels operated by or licensed to PMM in the PRC for the period commencing from the Effective Date to 31 March 2018 for promoting the businesses of the CMC Group. The maximum contract sum shall be RMB13,130,000 (equivalent to approximately HK\$14,817,205) (inclusive of sales tax). There is no minimum amount of advertisement required to be placed by CMC under the 2017 CMC Outdoor Advertising Contract.

The advertising fee of each advertisement will be agreed between PMM and CMC with reference to the rate card published by PMM from time to time which contains the pricing structure of the sale of advertisement airtime on the outdoor LED Panels. CMC will be provided with a discount around 90% off the rate card published by PMM after taking into account of the price offered by the major competitors of PMM, the actual local market condition and the advertising budget of CMC Group.

Under the 2017 CMC Outdoor Advertising Contract, CMC shall pay the advertising fees in arrears on a quarterly basis. Such advertising fees shall be paid by cheque, cash or telegraphic transfer within 20 business days immediately after receipt of invoice issued by PMM and the written confirmation issued by a third party consultancy company as agreed between the parties to monitor the broadcast conditions.

The actual transaction amounts incurred under the 2016 CMC Outdoor Advertising Contract during the contract term are RMB15,930,000 (equivalent to approximately HK\$17,977,005). The actual transaction amounts incurred between PMM and the CMCC Group for the period from 1 April 2016 to 30 April 2017 in aggregate are RMB20,605,600 (equivalent to approximately HK\$23,253,420).

### REASONS FOR AND BENEFITS OF THE 2017 CMC OUTDOOR ADVERTISING CONTRACT

PMM and/or its subsidiaries sell advertising airtime on the outdoor LED Panels operated by or licensed to them in their usual and ordinary course of business. Income generated from the sale of advertising airtime forms the major part of their turnovers. By selling advertising airtime to CMC, the Group is able to generate more income for its operation and business.

The 2017 CMC Outdoor Advertising Contract was entered into by the respective parties thereto after arm's length negotiation such that the advertising airtime on the outdoor LED Panels provided by the Group, through PMM, to other customers with similar purchase will be at rates no less favourable than that of the 2017 CMC Outdoor Advertising Contract. The total contract sum under the 2017 CMC Outdoor Advertising Contract was agreed between the parties with reference to the rate card published by PMM from time to time which contains the pricing structure for the sale of advertising airtime on the outdoor LED Panels, and the evaluation of the marketing and promotional activities of CMC in the PRC for 2017 and 2018.

#### IMPLICATIONS UNDER THE LISTING RULES

As Extra Step Investments Limited, a wholly-owned subsidiary of CMHKG, is a substantial shareholder of the Company, which, as at the date of this announcement, held approximately 19.69% of the issued share capital of the Company, and CMC, being an indirect subsidiary of CMHKG, is an associate of Extra Step Investments Limited, CMC is a connected person of the Company under the Listing Rules and accordingly the 2017 CMC Outdoor Advertising Contract constitutes continuing connected transaction for the Company under Chapter 14A of the Listing Rules.

As the applicable percentage ratios for the maximum contract sum under the 2017 CMC Outdoor Advertising Contract, MIGU Advertising Contract, the CMGG Advertising Contract, the 2016 CMGD Outdoor Advertising Contract and the 2016 CMC Outdoor Advertising Contract calculated on an aggregate basis exceed 0.1% but are less than 5%, the 2017 CMC Outdoor Advertising Contract and the Transactions are subject to reporting, announcement and annual review requirements but are exempt from the independent shareholders' approval requirements under Chapter 14A of the Listing Rules.

#### VIEWS OF THE DIRECTORS

The Directors (including the independent non-executive Directors) considered that the 2017 CMC Outdoor Advertising Contract was entered into on normal commercial terms or better and in the ordinary and usual course of business of PMM and/or its subsidiaries, and the relevant terms thereof and the maximum contract sum of RMB13,130,000 (equivalent to approximately HK\$14,817,205) are fair and reasonable and the Transactions are in the interests of the Company and the Shareholders as a whole.

Two of the Directors, namely Mr. SHA Yuejia and Mr. XIA Bing, have abstained from voting on the Board resolutions approving the 2017 CMC Outdoor Advertising Contract due to the fact that Mr. SHA Yuejia and Mr. XIA Bing are Directors nominated by a member of the CMCC Group. Save as disclosed above, none of the Directors has a material interest in the 2017 CMC Outdoor Advertising Contract.

#### **GENERAL**

The Group is a satellite television operator and, through its subsidiaries, is a leading satellite television broadcasting and provision of new media services.

CMHKG is the substantial shareholder of China Mobile Limited, which is a leading mobile telecommunications services provider in the PRC, providing mobile telecommunications and related services in all 31 provinces, autonomous regions and directly-administered municipalities throughout the PRC and in Hong Kong. The ordinary shares of China Mobile Limited are listed on the Stock Exchange and its American depositary shares are listed on the New York Stock Exchange.

CMC, a wholly-owned subsidiary of China Mobile Limited, acts as China Mobile Limited's network and business coordination center in the PRC.
