After due verification, the Bank would like to clarify as follows:

Champ Harvest Limited (the "Champ Harvest") is the controlling shareholder of China Huishan Dairy Holdings Company Limited (the "Huishan Dairy"), a company listed in Hong Kong. Champ Harvest pledged certain shares of Huishan Diary as collateral and obtained the credit lines from the Bank in June 2015. As of March 24, 2017, the outstanding borrowings of Champ Harvest with the Bank were HKD2.142 billion, and the total number of Huishan Dairy shares pledged by Champ Harvest was 3.434 billion. The Bank and its controlling shareholder, Ping An Insurance (Group) Company of China, Ltd. (the "Ping An"), do not hold any shares of Huishan Diary. At present, trading of the shares of Huishan Diary has been suspended and the Bank will take various measures to ensure the safety of the credit funds.
