The board of directors (the “Board”) and all directors of Ping An Insurance (Group) Company of China, Ltd. (the “Company”) confirm that there are no false representations and misleading statements contained in, or material omissions from this announcement, and severally and jointly accept the responsibility for the truthfulness, accuracy and completeness of the contents of this announcement.

The Resolution Regarding the Implementation of the Key Employee Share Purchase Scheme was approved at the 16th meeting of the 9th session of the Board held on October 28, 2014 and the first extraordinary general meeting of 2015 held on February 5, 2015, respectively. In accordance with the requirements as stated in the Guiding Opinions on the Pilot Implementation of Employee Share Purchase Schemes by Listed Companies (Zheng Jian Hui Gong Gao [2014] No.33) issued by China Securities Regulatory Commission and the Notice of Shanghai Stock Exchange on Issuing the Guidelines for Information Disclosure for Employee Share Purchase Scheme of Listed Companies (Shang Zheng Fa [2014] No.58), the implementation progress of the 2018 Key Employee Share Purchase Scheme of the Company is set out as follows:

The 2018 Key Employee Share Purchase Scheme of the Company was conducted in the secondary market on April 27, 2018. A total of 9,666,900 A shares of the Company (Stock Code: 601318) were purchased, representing 0.053%% of the total share capital of the Company. The aggregate transaction amount was RMB592,698,901.19 (expenses inclusive) and the average transaction price was approximately RMB61.29 per share.

The total number of personnel who voluntarily participated in the 2018 Key Employee Share Purchase Scheme of the Company were 1,296. After this share purchase, the shareholding of directors, supervisors, senior management and other staff of the Company under the 2018 Key Employee Share Purchase Scheme of the Company was as follows:

Pursuant to the Key Employee Share Purchase Scheme, after the end of the lock-up period, the actual number of shares shall be vested in the scheme holders subject to the achievement of certain performance targets.
