- (2) to receive a printed English version of all future Corporate Communication only; or
- (3) to receive a printed Chinese version of all future Corporate Communication only; or
- (4) to receive both the printed English and Chinese versions of all future Corporate Communication of the Company.

If we do not receive the Reply Form from you by 24 May 2010 and until you inform the Company (c/o the Company's H Share Registrar) by reasonable notice in writing by post or by email, you will be deemed to have consented to reading all future Corporate Communication published on the Company's website in place of receiving printed copies. Only a printed notification of the publication of the Corporate Communication on the Company's website will be sent to you in future.

Please note that both the English and Chinese versions of all future Corporate Communication will be available on the Company's website at <u>www.pingan.com</u> and the website of The Stock Exchange of Hong Kong Limited.
