Remarks (if any):

Reference is made to the circular of the Company dated 6 May 2019 (the "Circular") in relation to the proposed Share Consolidation. Unless otherwise defined, capitalised terms used herein shall have the same meanings as defined in the Circular.

As a result of the Share Consolidation, adjustments to the Existing Share Options are required under the terms and conditions of the relevant share option scheme of the Company in relation to the Existing Share Options which became effective on Thursday, 23 May 2019, being the date on which the Share Consolidation became effective. The number of Shares to be issued under the Existing Share Options and the exercise price per Share are adjusted accordingly.

As a result of the Share Consolidation and under the terms and conditions of the Convertible Notes, the conversion price adjusted from HK\$0.011 per Share to HK\$0.22 per Share and the outstanding Convertible Notes in the principal amount of HK\$158.4 million will be convertible into 720,000,000 Shares, with effect from the close of business in Hong Kong on Wednesday, 22 May 2019, being the day immediately preceding the date on which the Share Consolidation became effective.

Save for the above adjustments, all other terms and conditions of the Existing Share Options and Convertible Notes shall remain unchanged. For details, please refer to the announcements of the Company dated 23 April 2019 and 22 May 2019, and the Circular.
