The board (the "Board") of directors (the "Directors") of the Company wishes to inform the shareholders of the Company and potential investors that the Group is expected to report an estimated loss of around HK\$26.0 million for the six months ended 30 June 2022 (the "Reporting Period"), as compared with the loss of approximately HK\$23.8 million for the six months ended 30 June 2021 (the "Corresponding Period"). The estimated increase in the loss for the Reporting Period was mainly due to, among others, the increase in the operating loss for the electronic products business and the increase in imputed interest expenses on convertible notes. The increase in the operating loss for the electronic products business for the Reporting Period was mainly due to, among others, the decrease in revenue resulting from a shrink in orders for the Group's electronic components amid growing global inflation concern and as some of the giant consumer products manufacturers temporarily halted certain procurement orders according to their swelling inventories on hand.

As the Company is still in the process of finalising the interim results of the Group for the Reporting Period, the information contained in this announcement is only based on a preliminary assessment by the Board with reference to the management accounts of the Group and on the information available for the time being, but not on any data or information audited or reviewed by the auditor of the Company. Financial information and other details of the Group will be disclosed in the interim results announcement of the Group for the Reporting Period.
