Re: Placing of Placing Shares and Convertible Bonds

As disclosed in the announcements dated 19 January 2011, 11 February 2011, 30 March 2011 and the circular Dated 20 May 2011, the Company and the Placing Agent entered into a Placing Agreement on 17 January 2011 on a best efforts Basis. Resolutions in respect of the Placing Mandate and Placing Agreement were duly passed at the Special General Meeting of the Company held on 7 June 2011.

As disclosed in the announcement dated 6 July 2011, the commitments to subscribe for 2,200,000,000 Placing Shares and Convertible Bonds in aggregate amount of HK\$1,450,000,000 have been received from investors and the Placing Agent entered into a price determination agreement pursuant to which the Placing Price of each Placing Share is agreed to be HK\$0.4 and the Initial Conversion Price of the Convertible Bonds is agreed to be HK\$0.5.

All capitalised terms used shall have the same meanings as those defined in the mentioned announcements and the circular.
