- In the case of joint holders the vote of the senior who tenders a vote, whether in person or by proxy, will be accepted to the (f) exclusion of the votes of the other joint holder(s), and for this purpose seniority will be determined by the order in which the names stand in the register of members of the Company.
- To be valid, this form of proxy, together with the power of attorney (if any) or other authority (if any) under which it is signed (g) or a certified copy thereof, must be deposited with the Company's Share Registrar in Hong Kong, Secretaries Limited, at 26/F, Tesbury Centre, 28 Queen's Road East, Wanchai, Hong Kong not less than 48 hours before the time for the holding of the Meeting.
