Subject to our auditor's review, the expected loss was mainly attributable to:

(i) a fair value loss arising from revaluations of the investment properties of the Group amounting to be approximately HK\$119 million based on draft valuation reports prepared by an independent valuer (whereas fair value losses of approximately HK\$99 million and HK\$137 million were recorded for the six months ended 30 September 2021 and for the year ended 31 March 2022, respectively); and

(ii) a fair value loss on financial assets at fair value through profit or loss of approximately HK\$44 million (whereas fair value gains of approximately HK\$4 million and HK\$11 million were recorded for the six months ended 30 September 2021 and for the year ended 31 March 2022, respectively).
