- Net deficit attributable to members of NZ\$3.4 million (HK\$18.8 million) (2005: net surplus of NZ\$4.3 million (HK\$23.7 million)).
- Shareholders' equity attributable to members as at 31st December, 2006 of NZ\$99.5 million (HK\$548.7 million) (2005: NZ\$394.1 million (HK\$2,173.5 million)).
