SUMMARY OF POWER GENERATION FOR MARCH 2021

This voluntary announcement is made by Beijing Enterprises Clean Energy Group Limited (the "**Company**", together with its subsidiaries, the "**Group**") to keep the shareholders and potential investors of the Company informed of the latest business development of the Group.

The board (the "**Board**") of directors (the "**Directors**") of the Company announces that, according to the Company's preliminary statistics currently available, the power generation of the Group on a consolidated basis amounted to approximately 391,616 megawatt-hour ("**MWh**") for March 2021, representing an increase of approximately 6.3% compared with the corresponding period of 2020. For the three months ended 31 March 2021 (the "**Period**"), the aggregate power generation of the Group amounted to approximately 1,094,613 MWh, representing an increase of approximately 32.4% compared with the corresponding period of 2020.

The operating power generation* of the projects held and/or managed by the Group, the associates and the joint ventures of the Group for March 2021 was approximately 495,961 MWh, representing an increase of approximately 2.9% compared with the corresponding period of 2020. For the Period, the aggregate operating power generation of the projects held and/or managed by the Group, the associates and the joint ventures of the Group amounted to approximately 1,385,650 MWh, representing an increase of approximately 31.3% compared with the corresponding period of 2020.

* The operating power generation included (i) the power generation of the projects held by the Group, the associates and the joint ventures of the Group; and (ii) the power generation of the projects managed by the Group through the provision of entrusted management services.
