SUMMARY OF POWER GENERATION FOR MARCH 2022

This voluntary announcement is made by Beijing Enterprises Clean Energy Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) to keep the shareholders and potential investors of the Company informed of the latest business development of the Group.

The board (the “**Board**”) of directors (the “**Directors**”) of the Company announces that, according to the Company’s preliminary statistics currently available, the power generation of the Group on a consolidated basis amounted to approximately 439,952 megawatt-hour (“**MWh**”) for March 2022, representing an increase of approximately 9.9% compared with the corresponding period of 2021. According to the national electric power industry statistical data released by the National Energy Administration, the national average utilisation hours of wind power is representing a year-on-year decrease of 23% from January to February in 2022, influenced by that, for the three months ended 31 March 2022 (the “**Period**”), the aggregate power generation of the Group amounted to approximately 1,045,963 MWh, representing a decrease of approximately 6.3% compared with the corresponding period of 2021.

The operating power generation* of the projects held and/or managed by the Group, the associates and the joint ventures of the Group for March 2022 was approximately 538,807 MWh, representing an increase of approximately 8.6% compared with the corresponding period of 2021. For the Period, the aggregate operating power generation of the projects held and/or managed by the Group, the associates and the joint ventures of the Group amounted to approximately 1,258,311 MWh, representing a decrease of approximately 9.2% compared with the corresponding period of 2021.

* *The operating power generation included (i) the power generation of the projects held by the Group, the associates and the joint ventures of the Group; and (ii) the power generation of the projects managed by the Group through the provision of entrusted management services.*

Among them, details of the power generation of the Group's centralised photovoltaic power plants (including those held by the joint ventures of the Group) and wind power plants are set out as follows:
