SUMMARY OF POWER GENERATION FOR APRIL 2022

This voluntary announcement is made by Beijing Enterprises Clean Energy Group Limited (the "**Company**", together with its subsidiaries, the "**Group**") to keep the shareholders and potential investors of the Company informed of the latest business development of the Group.

The board (the "**Board**") of directors (the "**Directors**") of the Company announces that, according to the Company's preliminary statistics currently available, the power generation of the Group on a consolidated basis amounted to approximately 503,038 megawatt-hour ("**MWh**") for April 2022, representing an increase of approximately 13.5% compared with the corresponding period of 2021. For the four months ended 30 April 2022 (the "**Period**"), the aggregate power generation of the Group amounted to approximately 1,549,001 MWh, representing a decrease of approximately 0.7% compared with the corresponding period of 2021.

The operating power generation* of the projects held and/or managed by the Group, the associates and the joint ventures of the Group for April 2022 was approximately 612,086 MWh, representing an increase of approximately 12.6% compared with the corresponding period of 2021. For the Period, the aggregate operating power generation of the projects held and/or managed by the Group, the associates and the joint ventures of the Group amounted to approximately 1,870,397 MWh, representing a decrease of approximately 3.1% compared with the corresponding period of 2021.

* The operating power generation included (i) the power generation of the projects held by the Group, the associates and the joint ventures of the Group; and (ii) the power generation of the projects managed by the Group through the provision of entrusted management services.
