## **SUMMARY OF POWER GENERATION FOR JULY 2022**

This voluntary announcement is made by Shandong Hi-Speed New Energy Group Limited (the "Company", together with its subsidiaries, the "Group") to keep the shareholders and potential investors of the Company informed of the latest business development of the Group.

The board (the "Board") of directors (the "Directors") of the Company announces that, according to the Company's preliminary statistics currently available, the power generation of the Group on a consolidated basis amounted to approximately 428,969 megawatt-hour ("MWh") for July 2022, representing an increase of approximately 7.4% compared with the corresponding period of 2021. For the seven months ended 31 July 2022 (the "Period"), the aggregate power generation of the Group amounted to approximately 2,971,728 MWh, representing an increase of approximately 2.3% compared with the corresponding period of 2021.

The operating power generation\* of the projects held and/or managed by the Group, the associates and the joint ventures of the Group for July 2022 was approximately 482,553 MWh, representing an increase of approximately 1.3% compared with the corresponding period of 2021. For the Period, the aggregate operating power generation of the projects held and/or managed by the Group, the associates and the joint ventures of the Group amounted to approximately 3,545,140 MWh, representing an increase of approximately 0.01% compared with the corresponding period of 2021.

\* The operating power generation included (i) the power generation of the projects held by the Group, the associates and the joint ventures of the Group; and (ii) the power generation of the projects managed by the Group through the provision of entrusted management services.
