SUMMARY OF POWER GENERATION FOR SEPTEMBER 2022

This voluntary announcement is made by Shandong Hi-Speed New Energy Group Limited (the "Company", together with its subsidiaries, the "Group") to keep the shareholders and potential investors of the Company informed of the latest business development of the Group.

The board (the "Board") of directors (the "Directors") of the Company announces that, according to the Company's preliminary statistics currently available, the power generation of the Group on a consolidated basis amounted to approximately 431,930 megawatt-hour ("MWh") for September 2022, representing an increase of approximately 12.7% compared with the corresponding period of 2021. For the nine months ended 30 September 2022 (the "Period"), the aggregate power generation of the Group amounted to approximately 3,824,112 MWh, representing an increase of approximately 4% compared with the corresponding period of 2021.

The operating power generation* of the projects held and/or managed by the Group, the associates and the joint ventures of the Group for September 2022 was approximately 499,948 MWh, representing an increase of approximately 8.4% compared with the corresponding period of 2021. For the Period, the aggregate operating power generation of the projects held and/or managed by the Group, the associates and the joint ventures of the Group amounted to approximately 4,530,310 MWh, representing an increase of approximately 1.8% compared with the corresponding period of 2021.

* The operating power generation included (i) the power generation of the projects held by the Group, the associates and the joint ventures of the Group; and (ii) the power generation of the projects managed by the Group through the provision of entrusted management services.
