## **SUMMARY OF POWER GENERATION FOR NOVEMBER 2022**

This voluntary announcement is made by Shandong Hi-Speed New Energy Group Limited (the "**Company**", together with its subsidiaries, the "**Group**") to keep the shareholders and potential investors of the Company informed of the latest business development of the Group.

The board (the "**Board**") of directors (the "**Directors**") of the Company announces that, according to the Company's preliminary statistics currently available, the power generation of the Group on a consolidated basis amounted to approximately 339,201 megawatt-hour ("**MWh**") for November 2022, representing a decrease of approximately 10.6% compared with the corresponding period of 2021. For the eleven months ended 30 November 2022 (the "**Period**"), the aggregate power generation of the Group amounted to approximately 4,571,980 MWh, representing an increase of approximately 3.9% compared with the corresponding period of 2021.

The operating power generation\* of the projects held and/or managed by the Group, the associates and the joint ventures of the Group for November 2022 was approximately 409,014 MWh, representing a decrease of approximately 11.2% compared with the corresponding period of 2021. For the Period, the aggregate operating power generation of the projects held and/or managed by the Group, the associates and the joint ventures of the Group amounted to approximately 5,429,620 MWh, representing an increase of approximately 1.9% compared with the corresponding period of 2021.

\* The operating power generation included (i) the power generation of the projects held by the Group, the associates and the joint ventures of the Group; and (ii) the power generation of the projects managed by the Group through the provision of entrusted management services.
