SUMMARY OF POWER GENERATION FOR MARCH 2023

This voluntary announcement is made by Shandong Hi-Speed New Energy Group Limited (the "**Company**", together with its subsidiaries, the "**Group**") to keep the shareholders and potential investors of the Company informed of the latest business development of the Group.

The board (the "**Board**") of directors (the "**Directors**") of the Company announces that, according to the Company's preliminary statistics currently available, the power generation of the Group on a consolidated basis amounted to approximately 533,254 megawatt-hour ("**MWh**") for March 2023, representing an increase of approximately 21.2% compared with the corresponding period of 2022. For the three months ended 31 March 2023 (the "**Period**"), the aggregate power generation of the Group amounted to approximately 1,337,459 MWh, representing an increase of approximately 27.9% compared with the corresponding period of 2022.

The operating power generation* of the projects held and/or managed by the Group, the associates and the joint ventures of the Group for March 2023 was approximately 611,856 MWh, representing an increase of approximately 13.6% compared with the corresponding period of 2022. For the Period, the aggregate operating power generation of the projects held and/or managed by the Group, the associates and the joint ventures of the Group amounted to approximately 1,522,509 MWh, representing an increase of approximately 21.0% compared with the corresponding period of 2022.

* The operating power generation included (i) the power generation of the projects held by the Group, the associates and the joint ventures of the Group; and (ii) the power generation of the projects managed by the Group through the provision of entrusted management services.
