SUMMARY OF POWER GENERATION FOR JULY 2023

This voluntary announcement is made by Shandong Hi-Speed New Energy Group Limited (the "Company", together with its subsidiaries, the "Group") to keep the shareholders and potential investors of the Company informed of the latest business development of the Group.

The board (the "Board") of directors (the "Directors") of the Company announces that, according to the Company's preliminary statistics currently available, the power generation of the Group on a consolidated basis amounted to approximately 506,243 megawatt-hour ("MWh") for July 2023, representing an increase of approximately 18.0% compared with the corresponding period of 2022. For the seven months ended 31 July 2023 (the "Period"), the aggregate power generation of the Group amounted to approximately 3,453,330 MWh, representing an increase of approximately 16.2% compared with the corresponding period of 2022.

The operating power generation* of the projects held and/or managed by the Group, the associates and the joint ventures of the Group for July 2023 was approximately 555,483 MWh, representing an increase of approximately 15.1% compared with the corresponding period of 2022. For the Period, the aggregate operating power generation of the projects held and/or managed by the Group, the associates and the joint ventures of the Group amounted to approximately 3,877,235 MWh, representing an increase of approximately 9.4% compared with the corresponding period of 2022.

* The operating power generation included (i) the power generation of the projects held by the Group, the associates and the joint ventures of the Group; and (ii) the power generation of the projects managed by the Group through the provision of entrusted management services.
