## **SUMMARY OF POWER GENERATION FOR OCTOBER 2023**

This voluntary announcement is made by Shandong Hi-Speed New Energy Group Limited (the "**Company**", together with its subsidiaries, the "**Group**") to keep the shareholders and potential investors of the Company informed of the latest business development of the Group.

The board (the "**Board**") of directors (the "**Directors**") of the Company announces that, according to the Company's preliminary statistics currently available, the power generation of the Group on a consolidated basis amounted to approximately 439,061 megawatt-hour ("**MWh**") for October 2023, representing an increase of approximately 7.4% compared with the corresponding period of 2022. For the ten months ended 31 October 2023 (the "**Period**"), the aggregate power generation of the Group amounted to approximately 4,748,199 MWh, representing an increase of approximately 12.2% compared with the corresponding period of 2022.

The operating power generation\* of the projects held and/or managed by the Group, the associates and the joint ventures of the Group for October 2023 was approximately 471,376 MWh, representing a decrease of approximately 3.9% compared with the corresponding period of 2022. For the Period, the aggregate operating power generation of the projects held and/or managed by the Group, the associates and the joint ventures of the Group amounted to approximately 5,274,268 MWh, representing an increase of approximately 5.1% compared with the corresponding period of 2022.

\* The operating power generation included (i) the power generation of the projects held by the Group, the associates and the joint ventures of the Group; and (ii) the power generation of the projects managed by the Group through the provision of entrusted management services.
