SUMMARY OF POWER GENERATION FOR NOVEMBER 2023

This voluntary announcement is made by Shandong Hi-Speed New Energy Group Limited (the "**Company**", together with its subsidiaries, the "**Group**") to keep the shareholders and potential investors of the Company informed of the latest business development of the Group.

The board (the "**Board**") of directors (the "**Directors**") of the Company announces that, according to the Company's preliminary statistics currently available, the power generation of the Group on a consolidated basis amounted to approximately 464,543 megawatt-hour ("**MWh**") for November 2023, representing an increase of approximately 37.0% compared with the corresponding period of 2022. For the eleven months ended 30 November 2023 (the "**Period**"), the aggregate power generation of the Group amounted to approximately 5,212,742 MWh, representing an increase of approximately 14.0% compared with the corresponding period of 2022.

The operating power generation* of the projects held and/or managed by the Group, the associates and the joint ventures of the Group for November 2023 was approximately 499,394 MWh, representing an increase of approximately 22.1% compared with the corresponding period of 2022. For the Period, the aggregate operating power generation of the projects held and/or managed by the Group, the associates and the joint ventures of the Group amounted to approximately 5,773,662 MWh, representing an increase of approximately 6.3% compared with the corresponding period of 2022.

* The operating power generation included (i) the power generation of the projects held by the Group, the associates and the joint ventures of the Group; and (ii) the power generation of the projects managed by the Group through the provision of entrusted management services.
