## VOLUNTARY ANNOUNCEMENT COOPERATION AGREEMENT WITH BAODING PUBLIC TRANSPORT CORPORATION IN HEBEI PROVINCE

This announcement is made by Shougang Concord International Enterprises Company Limited (the "**Company**") on a voluntary basis.

On 24 January 2020, the Company (through its wholly-owned subsidiary, 首中投資管理有 限公司 (Shouzhong Investment Management Co., Ltd.\*, "Shouzhong Investment")) and Baoding Public Transport Corporation ("Baoding Corporation") entered into "Baoding Parking Lots Project Cooperation Agreement" (the "Cooperation Agreement"). The Baoding Parking Lots Project covers a total of 13,173 roadsides parking spaces distributed on 40 streets located in the core areas of Baoding, and a parking complex in a core area.
