PROPERTY SALES UPDATE FOR THE SECOND QUARTER ENDED 30 JUNE 2023

- For the second quarter of 2023, contracted property sales amounted to RMB3,034 million, comprising residential property sales of RMB2,890 million and commercial property sales of RMB144 million.
- For the second quarter of 2023, total gross floor area ("GFA") of contracted property sales were 54,900 square metres ("sq. m.") and 1,626 units of carpark.
- The average selling price of the signed contracts respecting property sales for the second quarter of 2023 was RMB55,600 per sq. m.
