For the year ended 31 December 2012, the Group's loss for the year amounted to US\$10,615,261 (equivalent to approximately HK\$82,268,273 under the exchange rate of US\$1.00 to HK\$7.75). For the period ended 30 June 2013, the Group's loss for the period

amounted to US\$953,168 (equivalent to approximately HK\$7,387,052 under the exchange rate of US\$1.00 to HK\$7.75). As at 30 June 2013, the Group had bank balances and cash of US\$317,397 (equivalent to approximately HK\$2,459,827 under the exchange rate of US\$1.00 to HK\$7.75).

The Directors consider that it is in the interests of the Company to raise capital from the equity market in order to maintain the cashflow position of the Group and to enhance the capital base of the Company. The Company will use the estimated net proceeds of the Subscription as general working capital.
