**CREATION OF VEHICULAR MULTIMEDIA FOCUS GROUP  
AT ITU SATELLITE CONNECTED-CAR MULTIMEDIA MOVING  
TOWARD GLOBALIZATION**

The International Telecommunication Union (ITU) has recently created the Focus Group for Vehicular Multimedia (VM-FG) at its ITU-T SG16 Annual Working Group Conference in July 2018.

The creation was spearheaded by Global Vision Media Technology Co., Ltd. (“Global Vision”), together with Telematics Industry Applications Alliance (TIAA) and industry partners from around the world.

The Vehicular Multimedia Focus Group’s purpose is to provide a platform for international cooperation in developing technology and application standards for innovative audio-video-data delivery into vehicles based on the converged “satellite mobile broadcasting + terrestrial cellular Internet” network architecture, which could offer unprecedented low-cost, high-quality, and wide-area coverage.

The Company is a pioneer and leader in satellite-terrestrial converged network and connected-car multimedia, with ample technologies and a global satellite converged network spanning across Asia, Africa and South Europe. It is currently deploying services in China and then will extend to other international markets.

The Company's Chief Technology Officer, Dr. Hui Liu made a presentation at the Conference on the satellite-based multimedia convergence ecosystem for connected cars – which is rooted in years of the Company R&D and China development experiences, and attested to the importance of forming the ITU Vehicular Multimedia Focus Group.

The creation of the Focus Group signifies substantial worldwide recognition in the Company's technological achievements, paving its way for global collaboration and adoption in the near future.

The Focus Group's creation was jointly proposed by Global Vision and TIAA and a total of 32 industry members from China and abroad. TIAA was elected the Chairmanship of the Focus Group, with Mr. Jun Li (Deputy Secretary General of TIAA as well as VP of Global Vision) as Chairman.
